## **Harbour View Presentation**

Harbour View Principal Francesca Ligman, along with teachers Jennifer de Lachica and Lietta Strecke, explained how the school is increasing academic achievement for all students through Multi-Tiered Systems of Support (MTSS) and differentiated instruction. In addition, Harbour View is the home of the Spanish Dual Language Immersion program. The entire school is now embracing language instruction and providing weekly Spanish classes for all grade levels!

## **Vista View Student Presentation**

Vista View Principal Dr. Rasheedah Gates informed the Board that 320 of her students were recently rewarded with a pizza party for achieving growth in both reading and math on their January i-Ready diagnostic assessments. Students Lexi Tran and Nicolas Tran voiced their support regarding student incentives for increased achievement. They also spoke about the many exciting electives and activities at Vista View, including marine biology, culinary arts, esports, leadership, dances, and spirit days.





## i-Ready Results

Dr. Julianne Hoefer, Assistant Superintendent of Educational Services, provided the Board with a review of how to interpret the District's i-Ready assessments results. The assessments are conducted three times a year in fall, winter, and spring. The data is used to inform instruction, check progress, and measure achievement. Ocean View School District (OVSD) students have shown marked growth in both reading and math this school year. The i-Ready data will be used by classroom teachers to identify skill gaps and then develop targeted instruction to further increase student achievement. See the presentation here.

## **Special Education Study Overview**

Ms. Chileen Spaulding, Director of Special Education, provided a presentation on a Special Education Study that was conducted to evaluate special education services in OVSD. The Special Education Department is working to address the study recommendations. Support programs include Student Study Teams (SST), Response to Intervention and Instruction (RTI2), and Multi-Tiered System of Supports (MTSS). <u>See the presentation here.</u>

### **Transportation Services Plan**

Mr. Jim Choate, Executive Director of Facilities and Transportation, spoke about Assembly Bill 181 and 185, which provides reimbursement funding for school districts that develop a Transportation Plan. This plan must include stakeholder input. The District will be eligible to receive reimbursement of \$375,000 after the Transportation Plan is approved by the Board and submitted to the State. <u>See the presentation here.</u>

#### **2nd Interim Report**

Keith Farrow, Assistant Superintendent of Administrative Services, provided the Trustees with the 2022-23 2nd Interim Budget Report. He discussed the most current budget information and OVSD's five significant budget challenges that include: declining enrollment, low schools enrollment, program contributions, staffing, and economic uncertainty.
