The Board honored the members of OVSD's School Attendance Review Board (SARB) for being designated as one of just six model programs in California! SARBs serve as critical safety nets for students with persistent attendance or behavioral problems. Our District uses a multi-tiered approach that includes early intervention, professional development, strategic staffing, family engagement and school connectedness. Our OVSD SARB is the gold standard in the state of California!

Bulletin Board Presentation - Summer Education Academy

Dr. Julianne Hoefer, Assistant Superintendent of Educational Services led a team presentation on our successful Summer Education Academy (SEA). The program was supported by 77 teachers and served 1,381 students over 19 days, with 76 hours of learning. The goals of the SEA were to increase student achievement through additional instruction; provide intensive, strategic support through smaller class sizes; and support social-emotional well being through interactions & relationship building. Mr. Jim Choate, Executive Director of Facilities, provided Measure R modernization updates on Vista View, Star View and Mesa View. He also spoke about completed summer projects including 8' perimeter fencing at Harbour View, the reestablishment of hardscape and softscape at Park View, and HVAC improvements at the District Office. Heating, Ventilation, Air Conditioning Update

Mr. Jim Choate, Executive Director of Facilities, spoke about the HVAC challenges the District is experiencing including some antiquated systems, lack of standardized Emergency Management Systems (EMS), difficulty finding and retaining qualified HVAC staff, and funding challenges. Measure R Citizens' Oversight Committee Appointments

The Measure R Citizens' Oversight Committee (COC) had several representative openings. The Board approved the appointment of Mr. Sal Hanna and Ms. Sally Frost to serve as Business Representatives and Ms. Crystal Mayer to serve as an Active Parent/Guardian of Child Enrolled in OVSD Representative. The purpose of the COC is to review expenditure reports to ensure that Measure R bond proceeds are used for the purposes set forth in Measure R. The COC also presents a Measure R annual report to the Board in public session that includes project updates, a financial summary, and a recap of the COC's activities.
