Message from the Superintendent

Dear New York Mills UFSD Families and Community,

I hope this issue of our newsletter finds you well and enjoying all that the spring season has to offer. This is the time during the school year where we not only prepare for many end-of-year activities, including commencement ceremonies, but also plan for the upcoming school year through the annual budget development process. One challenge for any school district, regardless of size, is to provide the very best educational program for its students within the means of the local taxpayers and state aid revenues. Under the leadership of the Board of Education and through careful fiscal management, the proposed 2024-2025 New York Mills Union Free School District budget reflects our commitment to supporting viable and vibrant programming for our children while remaining fiscally responsible to our taxpayers.

The proposed 2024-2025 school budget is \$16,900,275 with a 1.9% increase to the tax levy. The tax levy limit requires school districts in New York State to apply a multi-step formula to determine the tax levy a district can propose. We will once again stay within this tax levy limit. The \$16,900,275 spending plan results in a levy below the district maximum levy limit while supporting student programming and services. This budget also includes a capital outlay project with safety and security upgrades, including replacement of our fire hydrants, interior corridor doors, and other building infrastructure, as well as the purchase of a new bus which allows us to maintain and support district-operated transportation services. This spending plan aims to provide the best opportunities possible for our students in the most fiscally responsible way.

The New York Mills Union Free School District is committed to protecting the community's investments and providing our families with the necessary budget information to make an informed decision on Tuesday, May 21, 2024. Please review the budget information in this newsletter.

We invite all residents to attend the public hearing in the high school library of New York Mills Union Free School on Tuesday, May 7, 2024 at 5:30 p.m.

The budget vote will be held at Beekman Gymnasium on Tuesday, May 21, 2024. The polls will be open from 12:00 p.m.- 8:00 p.m. The May 21st vote also includes the election of members to fill two vacancies on the New York Mills Board of Education.

Your consideration of the 2024-2025 school budget is greatly appreciated. Thank you for your continued support of our district and our students!

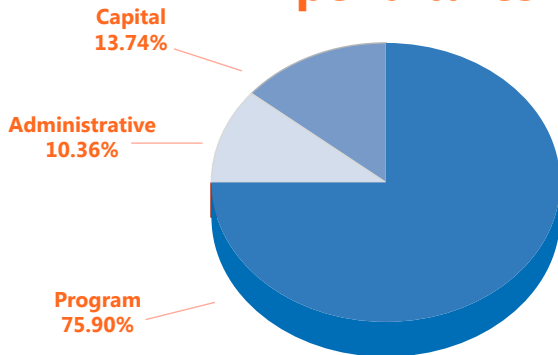

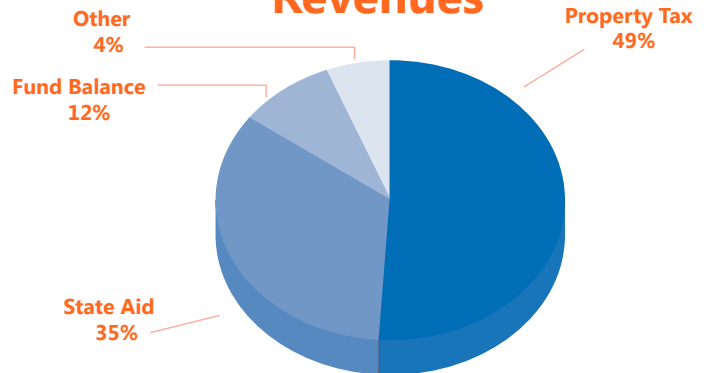

BUDGET PROPOSITIONS

PROPOSITION 1 - RESOLVED, that the Board of Education of the New York Mills Union Free School District is hereby authorized to expend the sum of \$16,900,275 as a general fund appropriation for the 2024-2025 school year and to levy the necessary tax therefor.

Tax Levy Increase

The tax levy increase for 2024-25 is projected to be 1.9%.

Tax on True

The tax on true value for the district in 2024-25 will be approximately \$16.71.

Note: Rates are estimated based on current information available. Final equalization rates will not be set by the State of New York until August. In the two previous years, the final tax on true was actually lower than projected at the time of budget development.

Absentee Ballots

Ballot Applications for absentee ballots must be received by the School District Clerk on or before May 14, 2024, if the ballot is to be delivered by mail, or on or before May 20, 2024, if the ballot is to be delivered personally to the voters. Absentee ballots must be received by the School District Clerk not later than 5 p.m. on the date of the election, May 21, 2024 .

Voter Eligibility Requirements

A voter must meet the following eligibility requirements to vote in school elections:

- Be a citizen of the United States.
- Have been a resident of the school district for a minimum of 30 days prior to the vote, including those who rent. Section 2018-C of the Education Law may require all persons who vote to provide one form of identification or proof of residency.
- Be at least 18 years of age.

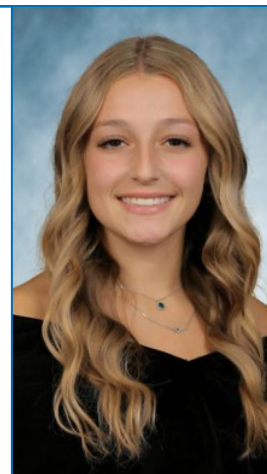
STUDENTS OF THE MONTH

Emily plans to attend Stony Brook University to study environmental design.

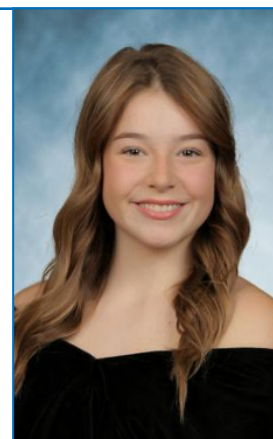


FEBRUARY - *Talan Marchese*

BATTLE *of the* Books



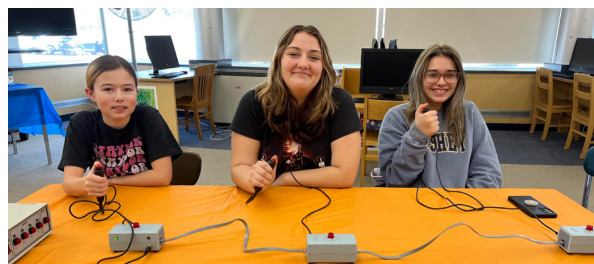
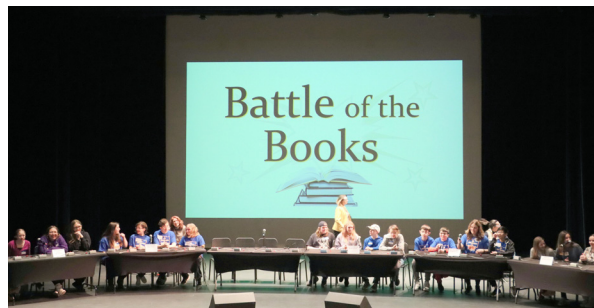
