- II. The Board of School Trustees will conduct an executive session pursuant to Indiana's Open Meeting Law, IC 5-14-1.6-6.1 (b) for the following reason(s):
  - a. X (2)(D) For discussion and strategy of a real estate property transaction including: (i) a purchase; (ii) a lease as lessor, (iii) a lease as lessee; (iv) a transfer; (v) an exchange; or (vi) sale; by the governing body up to the time a contract or option is executed by the parties. This clause does not affect a political subdivision's duty to comply with any other statute that governs the conduct of the real property transaction, including IC-36-1-10 or IC-36-1-11.
