Describe the data that analyzed to determine the effectiveness of the program and decisions made as a result:

The team analyzed reading and math data provided by the Dorchester Public School Continuous School Improvement Team/Process. Data included MAP Reading (Fluency and Growth), MAP Math (Growth), Wonders reading classroom data, and Big Idea Math classroom data. Staff members were trained using a "bookmark tool" to help students create personal MAP Goals. Throughout the school year, students and elementary staff members have worked with personal MAP Goals with the help of local ESU personnel in order to increase math and reading skills for grades K-6. At our end of the year elementary data meeting, we will look at the effectiveness of this tool and make plans for the new school year.

### List changes made to the Schoolwide Plan - if none, respond NA:

The Dorchester Public School Schoolwide Plan now is able to include math interventions through sixth grade. Up until this time, math interventions were only provided consistently through fifth grade.
