5 Searches and Seizure

6  
7 The goal of search and seizure with respect to students is meeting the educational needs of  
8 children and ensuring their security. The objective of any search and/or seizure is not the  
9 eradication of crime in the community. Searches may be carried out to recover stolen property, to  
10 detect illegal substances or weapons, or to uncover any matter reasonably believed to be a threat  
11 to the maintenance of an orderly educational environment. The Board authorizes school  
12 authorities to conduct reasonable searches of school property and equipment, as well as of  
13 students and their personal effects, to maintain order and security in the schools.

14  
15 The search of a student, by authorized school authorities, is reasonable if it is both: (1) justified  
16 at its inception, and (2) reasonably related in scope to the circumstances which justified the  
17 interference in the first place.

18  
19 School authorities are authorized to utilize any reasonable means of conducting searches,  
20 including but not limited to the following:

- 21  
22 1. A “pat down” of the exterior of the student’s clothing;  
23 2. A search of the student’s clothing, including pockets;  
24 3. A search of any container or object used by, belonging to, or otherwise in the possession  
25 or control of a student; and/or  
26 4. Devices or tools identified in District policy or the student handbook or deemed  
27 necessary by the Superintendent or designee which may include but are not limited to  
28 metal detectors, vapor detectors, vapor sensors, and smoke detectors. Notice of utilization  
29 of any device which may be considered surveillance will be posted in locations where  
30 such a device is in use.

31  
32 The “pat down” or “search” of a student, if conducted, will be conducted by a school official or  
33 employee of the same gender as the student being searched.

34  
35 Search Property and Equipment and Personal Effects of Students

36  
37 School authorities may inspect, and search school property and equipment owned or controlled  
38 by the District (such as lockers, desks, and parking lots).

39  
40 The Superintendent may request the assistance of law enforcement officials, including their use  
41 of specially trained dogs, to conduct inspections and searches of lockers, desks, parking lots, and  
42 other school property and equipment for illegal drugs, weapons, or other illegal or dangerous  
43 substances or material.

45 Students

1 School officials may search any individual student, his/her property, or District property under  
2 his/her control, when there is a reasonable suspicion that the search will uncover evidence that  
3 he/she is violating the law, Board policy, administrative regulation, or other rules of the District  
4 or the school. Reasonable suspicion shall be based on specific and objective facts that the search  
5 will produce evidence related to the alleged violation. The types of student property that may be  
6 searched by school officials include but are not limited to lockers, desks, purses, backpacks,  
7 student vehicles parked on District property, cellular phones, or other electronic communication  
8 devices.

9  
10 Also, by parking in the school parking lots, the student consents to having his/her vehicle  
11 searched if the school authorities have any other reasonable suspicion to believe that a violation  
12 of school rules or policy has occurred.

13  
14 Students may not use, transport, carry, or possess illegal drugs, including marijuana, or any  
15 weapons in their vehicles on school property. While on school property, vehicles may be  
16 inspected at any time by staff, or by contractors employed by the District utilizing trained dogs,  
17 for the presence of illegal drugs, drug paraphernalia, or weapons. In the event the school has  
18 reason to believe that drugs, drug paraphernalia, or weapons are present, and the student  
19 expressly consents to such a search, the student's vehicle will be searched.

#### 20 21 Seizure of Property

22  
23 When a search produces evidence that a student has violated or is violating either a law or  
24 District policies or rules, such evidence may be seized and impounded by school authorities and  
25 disciplinary action may be taken. As appropriate, such evidence may be transferred to law  
26 enforcement authorities.
