5 Applicant Rights and Consent to Fingerprint

7 As an applicant who is the subject of a national fingerprint-based criminal history record check for a
8 noncriminal justice purpose (such as an application for employment or a license, an immigration or
9 naturalization matter, security clearance, or adoption), you have certain rights which are discussed below.

- 11 • You must be provided written notification⁸ by Great Falls Public Schools that your fingerprints will be
12 used to check the criminal history records of the FBI.
- 13 • You must be provided, and acknowledge receipt of, an adequate Privacy Act Statement when you
14 submit your fingerprints and associated personal information. This Privacy Act Statement should
15 explain the authority for collecting your information and how your information will be used, retained,
16 and shared.
- 17 • If you have a criminal history record, the officials making a determination of your suitability for
18 employment, license, or other benefit must provide you the opportunity to complete or challenge the
19 accuracy of the information in the record.
- 20 • The officials must advise you that the procedures for obtaining a change, correction, or updating of
21 your criminal history record are set forth at Title 28, Code of Federal Regulations (CFR), Section
22 16.34.
- 23 • If you have a criminal history record, you should be afforded a reasonable amount of time to correct or
24 complete the record (or decline to do so) before the officials deny you the employment, license, or
25 other benefit based on information in the criminal history record.⁹

27 You have the right to expect that officials receiving the results of the criminal history record check will use it
28 only for authorized purposes and will not retain or disseminate it in violation of federal statute, regulation or
29 executive order, or rule, procedure or standard established by the National Crime Prevention and Privacy
30 Compact Council.¹⁰

32 If agency policy permits, the officials may provide you with a copy of your FBI criminal history record for
33 review and possible challenge. If agency policy does not permit it to provide you a copy of the record, you
34 may obtain a copy of the record by submitting fingerprints and a fee to the FBI. Information regarding this

37 If you decide to challenge the accuracy or completeness of your FBI criminal history record, you should send
38 your challenge to the agency that contributed the questioned information to the FBI. Alternatively, you may
39 send your challenge directly to the FBI at the same address as provided above. The FBI will then forward your
40 challenge to the agency that contributed the questioned information and request the agency to verify or correct
41 the challenged entry. Upon receipt of an official communication from that agency, the FBI will make any
42 necessary changes/corrections to your record in accordance with the information supplied by that agency.

The National Child Protection Act of 1993 (NCPA), Public Law (Pub. L.) 103-209, as amended by the Volunteers for Children Act(VCA), Pub. L. 105-251 (Sections 221 and 222 of Crime Identification Technology Act of 1998), codified at 42 United States Code (U.S.C.) Sections 5119a and 5119c, authorizes a state and national criminal history background check to determine the fitness of an employee, or volunteer, or a person with unsupervised access to children, the elderly, or individuals with disabilities.

2. Provide a certification that you (a) have not been convicted of a crime, (b) are not under indictment for a crime, or (c) have been convicted of a crime. If you are under indictment or have been convicted of a crime, you must describe the crime and the particulars of the conviction, if any.
3. Prior to the completion of the background check, the entity may choose to deny you unsupervised access to a person to whom the entity provides care.

The entity shall access and review State and Federal criminal history records and shall make reasonable efforts to make a determination whether you have been convicted of, or are under pending indictment for, a crime that bears upon your fitness and shall convey that determination to the qualified entity. The entity shall make reasonable efforts to respond to the inquiry within 15 business days.
