

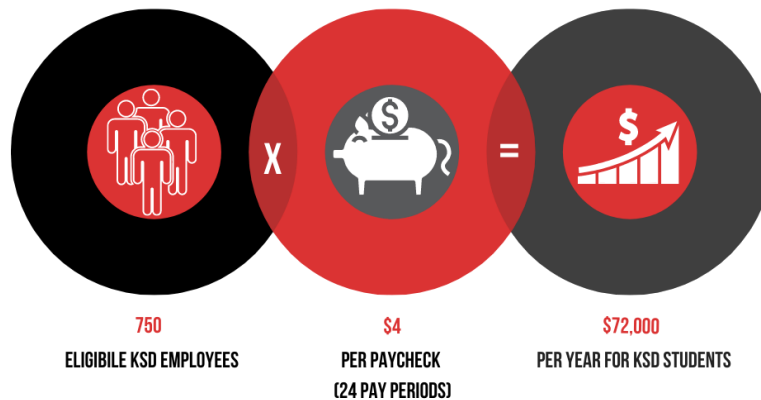

#### EACH DONATION MAKES A BIG IMPACT

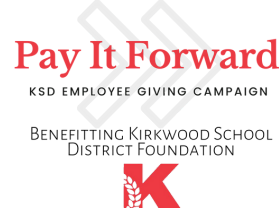
\$1 PER PAYCHECK =	\$24/YEAR
