Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

## Chemical pest management practices

- ✓ Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt from HAS recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at [www.cdpr.ca.gov/schoolipm](http://www.cdpr.ca.gov/schoolipm). (Education Code Section 16711)

(Education Code Section 17610.5)
