## 2023-24 School Description and Mission Statement

The Clearlake Creativity School is in Clearlake, California, and has served as a regionalized program for the students of Lake County for more than 10 years. The Clearlake Creativity School (CCS) is a program uniquely designed to suit the needs of students from within Lake County who have been diagnosed with emotional disturbance and are unable to make adequate academic progress in a general education setting. The NEEDS-SEB (Needs-driven, Equity-focused, Evidence-based, Designed to provide specialized instruction, Sustainable implementation model for Social, Emotional, and Behavioral supports) model is based on a multi-tiered system of supports (MTSS) and a token economy that are meant to improve student behavior, emotional regulation, and academic success. The program consists of 3 stages, and each stage allows the student to earn access to privileges, responsibility, and freedom similar to that of students in general education. Clearlake Creativity School serves approximately 28 students total in grades K-12, by strict adherence to Diana Browning Wright 's NEEDS-SEB program, with the goal of students being able to return to their home school once they have mastered the social and emotional skills necessary to be successful.

## 2023-24 School Safety Plan
