To support our Lake County students, the Lake County Office of Education operates Lloyd P. Hance Community School, providing an alternative learning environment for middle and high school students (7th – 12th grade) who are experiencing difficulties in a traditional school setting or who have been expelled from school, placed on probation by the court, or are otherwise referred by a school district, probation, or social service agency. The emphasis of the program is to reestablish the educational direction of students and to transition them back to their home district as quickly as possible.
