## ***Damage, Replacement and Reporting Technical Issues***

Any errors or problems with the Chromebook should be reported immediately to your teacher so it can be addressed in a timely manner. In the event of physical damage or neglect to a device, damage charges will be assigned to the student in order to purchase repair parts. Once repairs have been paid, a loaner device will be provided, if available. The current repair fee for parts or replacement are as follows:
