- 2. The first agenda item was House Bill 3, concerning measures for ensuring public school safety, including armed security for each campus. Updates were provided on school resource officer employment, upcoming steps including a proposed partnership with Milam County Sheriff, and the continued employment of School Resource Specialists.
- 3. Dr. Monzingo presented information on bond updates regarding security projects funded by the bond. Recently completed projects include RIS safety film, CTE fencing, RES Fencing, RJH fire lane, access card readers at all campuses and admin, and CCA doors. Upcoming projects include rekeying the district and completing security vestibules at RES, RJH, and RHS.

Susan Reinders from Milam County Emergency Management announced that her replacement Kenzie Oliver will start May 13. Mrs. Whitsel mentioned that the June meeting would review the district Emergency Operations Plans, with the next annexes due to TxSSC being Train Derailment and Cybersecurity.

- 6. In compliance with a State mandate, the committee received information regarding intruder audits and Threat Assessments.
