VII. Update: Student Enrollment

Mrs. Johnson shared an update of student enrollment, including a review of the enrollment forecasting process which begins with using birth rate data and applying mobility trends. As the District continues to monitor the two large enrollment "bubbles" currently in grades 5 and 6, staffing and materials will shift to align resources with these two classes. The average class size is currently 147, but grades 5 and 6 are at 171 and 182 respectively. Overall, enrollment is relatively stable, with a 5% swing of 2000 students over a 20 year period.

VIII. Discussion: Committee Structures

Mr. Weber led a discussion of best practices surrounding Board and Superintendent committees as we plan for 24-25 school year committee assignments. Mr. Weber reviewed guidance from OSBA and reviewed our policy structure. For 24-25, Community Engagement will no longer be a committee but will move to an "update" section on future agendas. All other committees will remain with meeting dates shared on the BOE online calendar.
