Dear Mr. Martinez:

Pursuant to Assembly Bill (AB) 1200 (Chapter 1213/Statutes 1992), AB 2756 (Chapter 52/Statutes 2004), and Government Code (GC) Section 3547.5, the Los Angeles County Superintendent of Schools (County Superintendent) has reviewed the Wiseburn Unified School District's (District) "Public Disclosure of Proposed Collective Bargaining Agreement" (Disclosure) concerning an agreement with the Wiseburn Faculty Association (WFA) bargaining unit. The agreement covers the period beginning July 1, 2023 through June 30, 2024. The Governing Board took action on January 18, 2024.

The agreement provides for a 4.00 percent on-schedule salary increase, effective July 1, 2023. Additionally, the agreement provides an increased District health and welfare contribution of \$1,000 from \$8,000 to \$9,000 benefit cap, and an hourly rate increase by \$10.00, from \$40.00 to \$50.00 per hour, effective January 1, 2024. The District's financial analysis, as reflected in the Disclosure, projects maintaining the minimum required reserves for the term of the agreement.

As a reminder, Education Code Section 42142 requires the District Superintendent to send to the County Superintendent any revisions to the District's current budget to fulfill the collective bargaining settlement within 45 days of adoption. AB 2756 and GC Section 3547.5(c) authorize the County Superintendent to take specific action if a school district does not process these revisions.
