## **EXPLANATION OF CODES**

The budget codes used in budget preparation and presentation are based on the accounting system required of school districts as established by the Comptroller of the State of New York. Under this accounting system, the basic code number consists of divisions of digits. The first set of numbers is used to designate each function or program and each function is further distinguished by a second set of numbers which designate the type of service (object) rendered for that function.

Each of the functions is generally self-explanatory and refers to specific functions such as Curriculum Development, Principals' Offices, etc. Most functions are further modified by two or more types of service. The meaning for each of these types of service (object code) is as follows:

## **GROUP**

### -1000- Salaries

The compensation that is paid to full or part-time employees of the school district where there is an employer-employee relationship.

## -2000- Equipment

This covers expenditures for the initial purchase or replacement of furniture and equipment. These are items which are of a permanent nature as opposed to supplies.

## -4000- Other Expenses

These are items not provided for under the other categories and include such items as postage, advertisement, freight, business travel, equipment repairs, building repairs, transportation, fuel oil, site based teams and gas, and consultant services.

### -4910- BOCES Services

All payments made to the Board of Cooperative Educational Services for any services provided by BOCES are included in this category.

## -5000- Supplies

This includes the cost of instructional supplies and materials, textbooks, library books, periodicals, cleaning materials, etc. Supplies are defined as items of an expendable nature that are consumed or worn out with use.

# -6000- Principal on Indebtedness

This code is used to designate principal payments on indebtedness.

## -7000- Interest on Indebtedness

This code is used to designate interest payments on indebtedness.

## -8000- Employee Benefits

This includes appropriations for the school district share of social security, Medicare, retirement, and various types of insurance for employee benefits.

Since 2012, the Library has been able maintain a budget that remains below the New York State cap limit. Due to the pandemic, the Library chose not to increase taxes last year and also became a "fine-free" library. After a great deal of consideration and review, the Library of Board of Trustees has developed a budget for 2021-2022 that allows the continued upkeep of our building and ensure our ability to maintain and increase services. The most important goal is to achieve this while having the absolute minimum impact on your library taxes. The Library Board of Trustees is proposing a budget for your consideration below the mandated 2021 New York State Tax Cap. This will amount to an estimated \$15.26 annually on a home assessed at \$40,000.

A Budget Informational Meeting will take place on May 11, 2021 at the Sayville School's Administration Building, beginning at 7:30 p.m.

You will be electing one Library Trustee this year for a five-year term. Debra Mitchell is the incumbent. All residents are encouraged to vote on Tuesday, May 18, from 7:00 am to 9:00 pm at the Suffolk Community College Center.

Applications for Absentee Ballots must be completed and returned to the Office of the District Clerk (Sayville Administration Building, 99 Greeley Avenue, Sayville, NY 11782) no later than ONE WEEK before Budget Vote Day if the absentee ballot will be mailed to the voter, or no later than ONE DAY before Budget Vote Day if the absentee ballot is to be hand delivered personally to the voter.

#### District Ability to Raise Local Funds

A school district's ability to raise local funds is classified as significantly more, slightly more, slightly less, or significantly less than the statewide average.

#### **District Student Needs**

Student needs in a school district are classified as significantly higher, slightly higher, slightly lower, or significantly lower than the statewide average.

#### **Economically Disadvantaged**

Economically disadvantaged students are those who participate in, or whose family participates in, economic assistance programs, such as the free or reduced-price lunch programs, Social Security Insurance (SSI), Food Stamps, Foster Care, Refugee Assistance (cash or medical assistance), Earned Income Tax Credit (EITC), Home Energy Assistance Program (HEAP), Safety Net Assistance (SNA), Bureau of Indian Affairs (BIA), or Family Assistance: Temporary Assistance for Needy Families (TANF). If one student in a family is identified as low income, all students from that household (economic unit) may be identified as low income.

#### **English Language Learners**

English Language Learners (ELLs) are those who, by reason of foreign birth or ancestry, speak or understand a language other than English and speak or understand little or no English, and require support in order to become proficient in English and are identified pursuant to Section 154.3 of Commissioner's Regulations.

#### **Needs Resource Capacity Categories**

The need/resource capacity index, a measure of a district's ability to meet the needs of its students with local resources.

Race or races with which the student primarily identifies as indicated by the student or the parent/guardian.

- American Indian or Alaska Native: A person having origins in any of the original peoples of North and South America (including Central America) and who maintains cultural identification through tribal affiliation or community recognition.
- Asian or Native Hawaiian/Other Pacific Islander: : A person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian subcontinent, including Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam; or a person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.
- Black or African American: A person having origins in any of the black racial groups of Africa.
- **Hispanic or Latino:** A person of Mexican, Puerto Rican, Cuban, Central or South American, or other Spanish culture or origin, regardless of race.
- White: A person having origins in any of the original peoples of Europe, North Africa, or the Middle East.
- Multiracial: Non-Hispanic students who are reported with more than one race.

#### Students with Disabilities

Students with disabilities are those who have been identified as such by the Committee on Special Education and are receiving services under the Individuals with Disabilities Education Act (IDEA). Students with disabilities include those having an intellectual disability; hearing impairment, including deafness; speech or language impairment; visual impairment, including blindness; serious emotional disturbance; orthopedic impairment; autism; traumatic brain injury; developmental delay; other health impairment; specific learning disability; deafblindness; or multiple disabilities and who, by reason thereof, receive special education and related services under the IDEA according to an Individualized Education Program (IEP), Individualized Family Service Plan (IFSP), or a services plan.





#### **ENROLLMENT BY GENDER**






#### **ENROLLMENT BY ETHNICITY**




