4. Health Service Update
 - a. Immunization Audits/State Report of Immunization Status:
In November the state performed an audit of the schools Immunization Records. They looked at kindergarten and 7th grade records for 2022-2023 school year. They flagged some charts because there was not a paper copy of student's immunization records, the missing records were corrected. A report for this school year was submitted and we are at 100% complaint. Currently working on hearing, vision, and spinal screenings currently.
5. Child Nutrition Update
Courtney Boullion did not have anything to update for Child Nutrition.
6. Hardin County Health Department Update
Ms. Riley with the Hardin County Health department spoke about preventive measures to keep sickness from spreading around, washing hands, and staying home when sick.
7. 2023-2024 SHAC Priorities Update
 - a. LifeVac-Deviser for choking. Plan on getting them on all campuses and buses.
 - b. Vaping Awareness-New law now there is mandatory placement in DAEP from the 88th Legislative Session if students are vaping at school or caught with a vape on them.
 - c. Fentanyl-we have Narcan on every campus, University of Texas provided that to us. We hope we never have to use it.
 - d. HOSA-Katie Stone, Vice President of HOSA, put out warnings about drugs they plan on doing once a month. They are waiting on information to have a coats and blanket drive for the

homeless. In February HOSA would like to sell candy grams to raise money for baskets to give to the nursing homes for Valentine's Day. At the end of the school year HOSA will go and visit LIT nursing program.
