2020-21 Step Increase Payout (Action)

She requested that the Board give ROMC employees the same consideration at Richland One employees. Tracy Dixon made the proposal to accept non certified staff that are eligible for the pay increase. During the summer, ROMC will have students participating in dual enrollment courses, summer school, and SC Virtual School classes.

Staff will be trained on Schoology and other professional development software during the summer.

Dr. Brabham informed the Board that we have received ninety-five applications (95) for the 2021-22 school year. Staff has been busily processing applications and we are looking forward to a great school year.

Dr. Fields shared with the Board that all district staff will be trained on Schoology and Safari Montage. The State Department of Education will be using Safari Montage as an instruction hub to share content. Due to the pandemic, many families are open to choice and the district is expanding these programs as well to offer a virtual school program at the elementary and secondary level.
