

# Bissonet Plaza's Family Engagement Policy

## PART I.

Bissonet Plaza Elementary agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required school level family engagement policies meet the requirements of section 1118 of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

1. Bissonet Plaza will take the following actions to involve parents in the joint development of its school family engagement plan under section 1118 of the ESEA:

*Literacy Night (Fall 2023)*  
*STEAM Night (Spring 2024)*

2. Bissonet Plaza will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

*-Title I Annual Parent Meeting to review plan, budget, and policies. This meeting will be included in Open House on August 23, 2023. .*

3. Bissonet Plaza will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional family engagement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:

*-Title I Annual Parent Meeting included in Open House (8/23/23)*

4. Bissonet Plaza will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:

*-Interims and report cards monitor progress towards mastery of state standards.*  
*-Curriculum and technology links are found on [bissonet.jpschools.org](http://bissonet.jpschools.org) and on [jpschools.org](http://jpschools.org).*  
*-Parent letters and test scores are sent home in August.*

5. Bissonet Plaza will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

*Monthly PTO Meetings*

6. Bissonet Plaza will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

*Student Report Cards are sent home in August from the LDOE.*

7. Bissonet Plaza will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

*-Teacher certification attestation letters are sent home*

8. Bissonet Plaza will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

- the state's academic content standards,
- the state's student academic achievement standards,
- the state and local academic assessments including alternate assessments,

- the requirements of Part A,
- how to monitor their child's progress, and
- how to work with educators:

*-JCampus parent portal directions/access sent home in August.*

*-Parent Testing Meeting for grade 3-5 in the spring 2024.*

*-Access to LDOE parent resources (Family Support Toolbox) sent in monthly newsletters.*

9. Bissonet Plaza will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster family engagement, by:

*-Family STEAM Night*

*-Family Literacy Night*

10. Bissonet Plaza will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

*-District provided ESL parent liaisons will be contracted as needed.*

11. Bissonet Plaza will, to the extent feasible and appropriate, coordinate and integrate family engagement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

*-Our campus does not have these resources, but our early intervention counselor assists with family resources as needed.*

12. Bissonet Plaza will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

*-Monthly Newsletters*

*-Bilingual paraprofessionals available to interpret meetings and translate documents.*
