INDIVIDUAL REFUND POLICY:

1) \$139 deposit is non-refundable, 2) Beyond the non-refundable portion, as of 8-23-24, portion of trip costs refundable to PST will be refunded to customer if PST is notified up to 30 days before departure date, 3) refunds requested to PST within 30 days of departure date will be made at the discretion of Prodigy Student Travel.

**** IF THE SCHOOL DECIDES TO CANCEL THE TOUR FOR SECURITY REASONS AT ANY TIME THRU 8-22-24, EACH STUDENT WILL RECEIVE A 90% REFUND OF THE TOTAL TRIP PRICE (\$719), MEANING PST WILL RETAIN \$80 EACH. SCHOOL CANCELLATION AS OF 8-23-24 WILL RESULT IN AN 88% REFUND OF THE TOTAL TRIP PRICE (\$703), MEANING PST WILL RETAIN \$96 EACH.**
