Through Parent and Family Engagement programming Corsicana Independent School District (CISD) is committed to strengthening our partnership with parents and the community in educating students. PART I. GENERAL EXPECTATIONS

Bowie Elementary agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required school level parental involvement policies meet the requirements of section 1118 of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.
- Schools will notify parents of the policy in an understandable and uniform format and, to the extent practicable, in a language the parents can understand. The policy will be made available to the local community and updated periodically to meet the changing needs of parents and the school.

1. **Bowie Elementary School** will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA:

 - *Parent - Teacher Conferences*

3. **Bowie Elementary School** will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:
 - *Posting Invitation in an understandable language on Campus Website, Class Dojo, reminder notes to students/families, and Campus Newsletter*
 - *Planning the Annual Meetings in conjunction with other well-attended programs*
 - *Providing snacks/treats*

4. The **Bowie Elementary** will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
 - *State's expectations posted on School's website for parents.*
 - *Provide information to parents at Parent/Teacher conferences at the end of the first 9 weeks.*

5. The **Bowie Elementary** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - *Parent Conferences- held on any given day during teacher's conference, before or after school. In person or byphone*
 - *504 Meetings*
 - *Tiger Cub Camp*
 - *ARD Meetings (Admission, Review and Dismissal)*
 - *Parent Information Night*

6. The **Bowie Elementary** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
 - *STAAR results mailed to parents within one week of notification to the campus.*
 - *All assessments and testing will be communicated to the parents.*

7. The **Bowie Elementary** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
 - *Bowie's goal is to have all highly qualified teachers.*
 - *Notified by parent letter that will go home with the student in a timely manner.*

8. The **Bowie Elementary** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators.

9. The **Bowie Elementary** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
 - *Math Activity Night with parents and students*
 - *Literacy Activity Night with parents and students*
 - *Library themed reading night with parents and students*
 - *Bilingual Family Literacy Night with parents and students*
 - *VOICE-Parenting Night/Family Involvement*

10. **Bowie Elementary** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- *Parent/Teacher Conferences*
- *Site Base Decision Committee Meetings*
- *PTO- Parent Teacher Organization*
- *Bowie School Programs and Performances*
- *Parent Information Night*

11. **Bowie Elementary** will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

- *VOICE -Parenting Night/Family Involvement*
- *Bowie Programs and Performances*
- *Grade level parent/teacher conference, Students meetings*


PART IV. ADOPTION
