Mr. Dean stated that he was then told that he should have received an email response and claimed that he had not. He is still awaiting a response. Mr. Dean then said that he is waiting for a response from Mrs. Wheeler in regards to procedures on how people can get on the committee for curriculum review. He requested a form for a formal protest in response of the curriculum used in the Berea City School District. Mr. Dean said that BCSD is in violation of three state statutes. Steve Mehozonek, Berea resident, began by congratulating Mrs. Farris on her new role as BOE President. He went on to say that he hopes the public participation portion of the meeting returns to being live-streamed.
