1. Welcome

1.1 Call to Order - Board President

Mr. Keith called the meeting to order at 7:02 P.M.

Mr. Keith outlined meeting protocol:

Mr. Keith thanked everyone for their civility and gave a reminder to be respectful of differing opinions.

3. Report of the Student Representatives to the Board

3.1 Student Representatives Update on Activities and Events at Souderton Area High School

Senior Aiden Kearns reported on recent high school events including The Art & Soul Fest which featured student artists, musicians and a preview of Les Miserables. He also commented on the inaugural season of the girls flag football team which will begin playing in April.

Senior Emma Potter reported on the Red & White competitions which are new activities created to foster school spirit. She also reported on the recent Academic Decathlon which the team finished 2nd place. Emma also commented on the 5th Grade Expo held at the high school, when all district fifth graders have the opportunity to learn about Career Pathways and how their school classes and courses will build toward career interests. Emma also noting the upcoming blood drive, junior prom, the start of spring concert season and the end of the third marking period. Superintendent Gallagher invited both of the student representatives to attend the Montgomery County Intermediate Unit Legislators Breakfast in April. He stated that details would be provided to them.

Superintendent Gallagher commented on the recent television feature showcasing the High School Interact Club volunteering at the Care & Share Thrift Shoppes in Souderton. He also noted Youth Art Month and Music in our Schools Month. Superintendent Gallagher also noted field trip season and thanked parents for chaperoning these events. He noted the upcoming high school trip to Spain, which 42 students will be joining. Dr. Gallagher also commented that today is World Down Syndrome Day and that students and staff across the district could be seen "rocking their socks."

Superintendent Gallagher also commented on his attendance to a recent legislative event to advocate on behalf of public education funding. He noted that the Pennsylvania House and Senate continue to debate various budget proposals.

Superintendent Gallagher spoke on his comment at the last Committee meeting that charter schools are aware of students who possess an IEP, therefore providing those schools with additional funding. Dr. Gallagher corrected his statement, acknowledging his misunderstanding of the lottery process for charter school enrollment. He stated that the schools are not aware if a student is a regular ed or special education student prior to enrollment.
