English Learner Advisory Committee (ELAC) Record of meeting January 26, 2024, 9:00AM Zoom/In-Person Meeting

- I. Welcome: Ms. Lujano welcomes and begins the meeting at 9:08 a.m.
- **II. Approval of Meeting Minutes/Agenda:** Ms. Kayla makes the first motion to approve the minutes and meeting minutes and Ms. Emily Arteaga makes the second motion.
- III. Principal/Assistant Principal Report: Mrs. Ramírez welcomed you and announced that we will soon have conferences. ELPAC testing will begin in late February and is important for English Learner students to monitor their progress in the English language. There will be another meeting soon to discuss ELPAC and reclassification in more detail. The basketball season is about to end.
- **IV. Peer Pressure:** Ms. Magaña presented on Peer Pressure, how to identify peer pressure and how to support her children with peer pressure. Social pressure occurs when values of social norms are adapted, having the influence of peers and society. Pressure can have positive and negative influences. There are three types of peer pressure: direct social pressure (when people tell you what to do and make you feel like you have no choice), indirect social pressure (when you influence your life through what you see and hear, tiktok, video games, social networks) and individual social pressure (when you put pressure on yourself).
- V. Proposal 28: SCHOOL SITE funds to complement arts and music education in schools from TK to 12th grade. 80% of the funds will be for certified and classified personnel. 19% will be for training and supplies and 1% for administrative costs. The information was presented at the school site meeting to take suggestions. The plan will be written between now and the end of the year so that it can begin at the beginning of the next school year. Soria received an amount of \$152,791 of which \$122,233 will be for salaries. Once the plan has been established it needs to be presented to the board of directors for the board to approve it. The school will be given 3 years to spend the funds. The plan wishes to be certified each year. Classes will be offered during school hours.
