Budget Edition 2024

Dear Marcellus Community,

On Tuesday, May 21st, Marcellus Central School District residents will vote on the district's proposed \$41,709,230 budget for the 2024-2025 school year. The budget calls for a 3.75% increase in spending and includes a tax levy increase of 3.60%, which is slightly less than our calculated tax levy cap of 3.62%. Because the increase in the levy is less than the calculated cap, a simple majority approval is required for passage of the 2024-2025 budget.

"When we kicked off the budget development process in January we had a projected budget gap of \$669,526," Business Administrator Anthony Sonnacchio said. "As details unfolded and efficiencies were identified, we were able to mitigate the gap." The fiscal plan maintains existing programs, including funding for our Universal Pre-Kindergarten classrooms. Like you, as a district, we are experiencing challenges related to inflationary costs. We are committed to providing our students with excellent programming, and at the same time are keenly aware of the need to remain fiscally responsible. To that end, our administrative team worked diligently to assess our staffing needs. As the budget process progressed we were able to identify opportunities to reduce staff primarily through attrition and maintain quality programming for our students.

Our school community has seen several improvements to our facilities over the past calendar year. Locker room renovations and auditorium/gymnasium window replacement were completed at the Driver Middle School. Reconfiguration and paving of the roadways and high school parking lot have been a welcome change. In addition to a designated student drop off location, the increased number of parking spaces has been helpful to parents and community members coming to campus for events. Construction of the Career Exploration and Agricultural Science building has begun. The foundation is taking shape for this flexible space that will house our Agriculture and other Career and Technical Education programs.

Residents will also elect two members to the Board of Education, decide on a proposition to replace two sixty-six passenger school buses and one thirty passenger school bus, and decide on the Marcellus Free Library's proposition to increase their funding by 2.8% in 2024-2025. We have four community members running for the two open Board of Education seats. Profiles for each candidate can be found on the last page of this document.

Voting will take place in the Senior High School Auditorium on Tuesday, May 21st from noon until 9:00 PM. Applications for absentee and early voting ballots are also available on the district's website, via email at colearly@marcellusschools.org, or by contacting the district office at 315-673-6009.


THREE-PART BUDGET

All public schools in New York State are required by law to report their spending in three categories: Administrative, program and capital.

Administrative: includes expenses for Board of Education, central administration, finance and legal services, personnel, public information, some facilities operations, central services, special items, supervision of regular school and some employee benefits.

<u>Programs</u>: includes expenses for curriculum development, instructional programs, supplies, district information, athletic programs, community service, most employee benefits and transfers of funds.

<u>Capital:</u> includes most expenses for facilities operations, all maintenance, debt service principal and interest on all building projects.

Proposition #1: Budget Adoption

"Shall the Board of Education of the Marcellus Central School District be authorized to expend the sums set forth in the total amount of \$41,709,230 for the 2024-2025 school year and to levy the necessary tax therefore?"

Proposition #3: Library Levy

"Shall the annual appropriation for the Marcellus Free Library be increased from its current level of \$563,600 per year to \$579,445 per year (an increase of \$15,845), to be raised by the levy of a tax upon the taxable property within the Marcellus Central School District, in accordance with Section 259 of the Education Law?"

DEFEATED BUDGET COULD MEAN \$773,203 IN REDUCTIONS

If the proposed 2024-25 budget is defeated by voters May 21, the Marcellus Board of Education will have the option of putting the same or a revised budget up for a revote, or adopting a contingent budget. If voters reject the proposed budget twice, the district must adopt a contingent budget.

Adopting a contingent budget would prohibit Marcellus from spending any money in certain areas, including community use of school facilities (unless all costs are reimbursed to the district); new equipment purchases; non-essential maintenance; capital expenditures (except in emergencies); salary increases for non-union employees; and certain field trips and student supplies. Contingency rules also cap the growth of the administrative component of the budget.

More significantly, under the law, if Marcellus adopts a contingent budget, the district would have to keep its 2024-25 tax levy the same as or less than its 2023-24 tax levy—in effect a 0 percent increase. In other words, the district would have to levy the same amount of taxes as the current year (or less) and as a result would—absent the use of additional reserve funds—need to reduce costs by \$773,203, without any adjustments for state pension rate increases, contractual obligations or any other costs, whether or not they are mandated.

Proposition #2: Purchase of Transportation Vehicles

"Shall the Board of Education ("Board") of the Marcellus Central School District ("District") be authorized to purchase student transportation vehicles for a combined maximum estimated expenditure of \$516,605, and to obtain the necessary funds by the levy of a tax upon the taxable property of the District, to be collected in annual installments in the years and in the amounts as the Board shall determine in accordance with Section 416 of the Education Law, and, in anticipation of such tax, to issue up to \$516,605 of obligations of the District?"

WHERE DO MARCELLUS CENTRAL SCHOOL DISTRICT REVENUES COME FROM?

Marcellus Central School District receives revenue to support its programming from several sources. The principal sources are New York state aid and local property taxes. State funding accounts for 39.2% of the districts projected revenue for 2024 -2025. The district proposes to appropriate \$1,887,862 in fund balance to offset any additional increase in the property tax levy.

BOARD OF EDUCATION CANDIDATES

On May 21 Marcellus residents will elect two members of the Board of Education. The following candidates filed petitions with the district office by the April 22 deadline. The two candidates with the highest number of votes will each serve a three-year term beginning July 1, 2024, and ending June 30, 2027.



JUSTIN PRITCHARD, of Marcellus, is seeking his first term on the Board of Education. A district resident for 12 years, he is the Director of the Learning Center and English Language Institute at Onondaga Community College where he oversees academic support initiatives and works to support professionals to support student success.

Justin and wife Jackie have two daughters. Vivienne (12) is in 7th grade at Bishop Ludden Jr/Sr High School and Juliet (10) is in 5th grade at Driver Middle School.

Justin holds a bachelor's degree in English with a minor in Education from LeMoyne College. He also attended SUNY Cortland where he earned his master's degree in English and Syracuse University where he acquired his CAS in Language Teaching: TESOL/TLOTE.
