1 GENERAL POLICIES GOVERNING BIDS

The Tuscaloosa County Board of Education proposes to make all purchases in accordance with Alabama Law. As we understand it, the purposes of the 1967 State Bid Law are: (1) to enable the Boards of Education (and other public agencies) to get maximum value in goods and service for the money spent, and (2) to give responsible business concerns a fair opportunity to share in business created through public expenditures.

Under the law, the Board of Education has the right to reject any or all bids and to consider quality, suitability to purpose, delivery dates, responsibility of bidders and other factors in selecting the products to be purchased and determining the successful bidders. The Board of Education will select in each case what it considers to be the best product for the price.

Records showing the bids received and prices paid for each item will be placed on file and may be examined by the public upon request. If an order is awarded to someone other than the lowest bidder, a note of explanation will appear in bid records. Mail inquiries about quotations will not be answered.

2 INSTRUCTIONS FOR BIDDING

1. Bids must be written or typed on this form (or its attachments). Price quotes for bid items **MUST** be submitted on flash drive using the excel document provided. **FLASH DRIVE PROVIDED or may scan spreadsheet to own.**
2. Bidder must give make and model number (if any) and provide such specifications, descriptions and illustrations as are needed to establish the nature and quality of the goods offered and must be prepared to make a sample available for inspection upon receipt.
3. Mail or send bid to the address at the head of this page and mark outside of the sealed envelope the number of this bid shown below. "BID #2555."
4. Bids including flash drives must be in the Board of Education Office by the date shown below.
5. Bids will be received until the date and hour set herein.
6. Samples should be submitted, if possible, before the bid opening.
7. Tailgate delivery WILL NOT be acceptable. Goods must be set inside the building.
8. All purchases shipped or delivered "Pre-paid" and shall be bid accordingly.

Purpose

The purpose of this Invitation to Bid is to establish a contract or contracts between the Tuscaloosa County School System, and Distributors for milk products and the distribution of those items. This contract will establish a maximum price that participating schools will pay for any item covered by the contract during the term of that contract.

The successful distributor will be responsible for purchasing, warehousing and distributing the milk and milk products. Distributors are obligated to furnish the items covered by the contract at prices that do not exceed the contract price.

Introduction and Background

The Tuscaloosa County School System seek written bids for fee for service contracts from qualified vendors able to provide milk and dairy products.

The contractor must be able to deliver or contract with a distributor to provide the specified end products and ensure the return of quantity, quality and value.

Sealed, written bids will be received by the school systems at the time and place specified on the Request for Bid. Dating of bid form or placing in mail by bid opening date will not meet requirements. Bid must be received on/or before date and time stated. The school systems reserve the right to reject any and all bids and to waive any and all informalities.

Return Instructions

Bids shall be submitted in compliance with the following criteria:

- A. Bids must be submitted signed and sealed to the location specified on the Invitation to Bid. The bid file number, time and date of bid opening and the term, "Milk Bid" shall be noted on the face of the envelope in the lower left corner.
- B. Bids delivered in Federal Express, UPS, or any other such deliverer's envelope shall be sealed in a separate envelope inside the deliverer's packaging. Failure to do this may cause the bid to be inadvertently opened and thus rejected. **Bids sent via regular or express mail must be sent to the Tuscaloosa County Schools, 1118 Greensboro Ave, Tuscaloosa, AL 35401.**
- C. Fax bids will not be accepted.
- D. Only bids submitted on bid forms furnished with this solicitation or copies thereof will be considered. **Signed bid form must be original signature.**
- E. The bid contract must be used without alterations.
- F. Invitation to Bid, Bid Form, and Debarment Certification Form Section IV, and Section V, and Section VI shall be in a sealed envelope with the company name, bid file number and opening date on the outside of the envelope. It should be marked "Bid Documents". Bid documents shall be placed in an envelope as set forth above for mailing or delivery to the Tuscaloosa County Schools, 1118 Greensboro Ave, Tuscaloosa, AL 35401. All pages or sections marked *****This form must be completed and returned****** must be returned with the bid. The envelope containing Bid Document shall be plainly marked in the lower left corner **"Bid #2555"** and shall have the name and return address of the bidding company appropriately shown on the face of the envelope.

Term of Contract

The contract term will be for July 1, 2024 through June 30, 2025 (the 24-25 SY) with an option to renew for three additional 12-month periods. If manufacturer costs increase significantly, bid prices per manufacturer may be increased up to 5% upon bid renewal.

Scope of Work

- This bid is for the purchasing of grocery products for the Tuscaloosa County System.
- The contractor must consistently deliver to all 35 schools in the district on approved designated delivery days between the hours of 6:30 am and 2:30pm.
- Late trucks must be reported and depending on staff availability may be received next day.
- The winning vendor is to exhibit reasonable flexibility when delivering to schools to accommodate unforeseen circumstances such as weather delays/closures or security measures that may limit access to the buildings. When such unforeseen circumstances arise, the vendor is to schedule a mutually agreed upon alternative delivery day.
- Delivery trucks delivering fresh, frozen or refrigerated items shall be clean, well-organized to promote expedient unloading and must be temperature controlled.
- Frozen items must be delivered solidly frozen without evidence of thawing and refreezing and refrigerated items must be delivered at a maximum internal temperature of 41 degrees.
- Delivery drivers are to be courteous and professional and deliver all products to their respective storage areas- dry storage, cooler and/or freezer. TCSS staff are responsible for shelving.
- All items ordered for delivery shall be delivered exactly as ordered unless a pre-approved equal substitution is arranged in advance.
- A list of outs must be provided in a timely fashion to allow substitutions to be arranged in time for delivery.
- The successful vendor must be able to stock, maintain and deliver in sufficient quantity with consistency so as to minimize the need for frequent menu changes.
- The successful vendor must be able to provide CN labeling, and other nutritional product labeling for all products used. This data must be digital or accessible via internet and available upon request.
- The successful vendor must be able to receive grocery orders either in digital format (csv file) or via an online ordering system that is compatible with the district inventory management system (Mosaic).
- The winning vendor must be able to exhibit reasonable flexibility and creativity to reasonably add to product line ups when new products become available and are desirous to the district.
- The successful bidder must be able to provide a detailed invoice with each delivery clearly indicating the delivery date, site, number, quantity and cost of each item and whether or not the item was fulfilled or substituted.
- The successful bidder must ensure that the bid cost of each item is accurately reflected on the invoice without errors or changes to the bid price except if mutually agreed upon at contract renewal.
- The successful bidder must provide excellent and courteous customer service and have representatives readily available by phone, text and email to provide prompt resolution to issues.

Standard Contract Conditions

- A. This contract shall be governed in all respects to validity, construction, capacity, performance or otherwise- by the laws of the State of Alabama and the United States.
- B. Contractors providing service under this Request for Bid, herewith, assure the school system that they are conforming to the provision of the Civil Rights Act of 1964, as amended.
- C. Contractors shall comply with Executive Order 11246, entitled "Equal Employment Opportunity", as amended by Labor regulations (41CFR Part 60).

- D. State Sales and Use Tax Certificate of Exemption form will be issued upon request. Sales tax shall be included in prices where applicable.
- E. Contractor shall comply with applicable Federal, State and local laws and regulations pertaining to wages, hours, and conditions of employment. In connection with contractor's performance of work under this contract, contractor agrees not to discriminate against any employee(s) or applicant(s) for employment because of age, race, color, religion, sex, national origin or disability.
- F. The contractor agrees to retain all books, records and other documents relative to this agreement for three (3) years after final payment. The system, its authorized agents, and/or State/Federal representatives shall have full access to, and the right to examine any of said materials during said period. If an investigation or audit is in progress, records shall be maintained until slated matter is closed.
- G. Any product offered which is not labeled in such a manner as to permit Interstate transport will be rejected. Packers and or producers located within the State of Alabama must understand that Alabama Department of Agriculture inspection labels will not qualify under provisions of this Invitation to Bid.
- H. Contractor shall comply with all applicable standards, orders or requirements issued under Section 306 of the Clean Air Act (42 U.S.C 1857[h]), Section 508 of the Clean Air Act (33 U.S.C. 1368), Executive Order 11738 and Environmental Protection Agency regulations (40 CFR Part 15), which prohibit the use under non-exempt federal contracts, grants or loans of facilities included on the EPA List of Violating Facilities.
- I. By signing this document, the contractor certifies that this bid is made without prior understanding, agreement or connection with any other corporation, firm or person submitting a bid for the same materials, supplies, or equipment, and is in all respects fair and without collusion or fraud. The contractor certifies that collusive bidding is a violation of Federal law and can result in fines, prison sentences and civil damage awards.
- J. Prohibition against conflicts of interest, gratuities and kickbacks; Any employee, any official of the school system elective or appointive, who shall take, receive or offer to take or receive, either directly or indirectly, any rebate, percentage of contract, money or other things of value as an inducement, in the procurement of business, or the giving of business, for, or to, or from, any person, partnership, firm, or corporation, offering, bidding for, or in open market seeking to make sure sales to the school system shall be deemed guilty of a felony and upon conviction such person or persons shall be subject to punishment of a fine in accord with State and/or Federal laws.
- K. The contract distributor shall be liable for gross receipt taxes in accordance with Alabama statutes if applicable.

Bidder Responsibility

It shall be incumbent upon each bidder to understand the provisions of this bid document and, when necessary, obtain clarifications prior to the time and date set for the bid opening. Failure to obtain a clarification will be no excuse or justification for noncompliance with the provisions set forth herein.

Unit Price

All prices shall be firm for the duration of the contract. A 5% increase may be negotiated before contract renewal. The contractor may lower prices at any time.

Liability

Subsequent to the awarding of a contract, the contractor will be liable for any expense, including legal fees incurred by the Tuscaloosa County Board of Education or as a result of violations of the contract terms by any contractor.

Buy American

Vendor must be in compliance with the Buy American provision. Section 104(d) of the William F. Goodling Child Nutrition Reauthorization Act of 1998 (Public Law 105-336) added a new provision, Section 12(n) of the NSLA (42 USC 1760(n)), requiring SFAs to purchase domestically grown and processed foods, to the maximum extent practicable. Purchases made in accordance with the Buy American provision must still follow the applicable procurement rules calling for free and open competition.

Prohibition on the Use of Chicken from China

In Section 751, of Division A of the Appropriations Act, Congress provides that funds made available by the Appropriations Act cannot be used to procure raw or processed poultry products imported into the United States from the People's Republic of China for use in any CNP. Consistent with the terms of the Appropriations Act, this memorandum provides notice to CNP operators that program funds may not be used to procure raw or processed poultry products from the People's Republic of China. This legislation extends the existing prohibition through Sept. 30, 2023.

Product Buy Change

Participating districts reserve the right to change the product mix as new products become available or student preferences change. Participating districts will not change any more than ten percent of the products.

Product Specifications and Protection Guarantees

Fluid milk and milk products shall be manufactured and packaged as defined in the Rules of State Board of Health, Bureau of Environmental Services, Division of Food, Milk, and Lodging Chapter 420-3-16, Production Processing, Handling or Distribution of Milk, Milk Products and Frozen Desserts, as published by the State Board of Health. Milk and milk products shall be pasteurized, homogenized and vitamin fortified. Fluid milk shall be delivered at a temperature of 40 degrees or less. Any milk delivered above 40 degrees may be rejected or returned for credit if spoilage occurs. Participating Organizations have "automatic" product protection recourse against suppliers for product safety. According to federal regulations, the supplier whose name and address appear on the package is the responsible party. Contractors are expected to take immediate action to correct any situation in which product integrity is violated. See Product Specification.

Quantity

The district does not guarantee orders in the amounts listed nor shall the districts be required to limit its orders to specific figures. This is an indefinite quantity bid based on estimated usage and average daily participation. The amounts shown are estimates only. The districts do not guarantee any specific usage but the following represents the current meal participation. See Exhibit A.

Pack Size

The contractor will maintain the pack size during the term of the contract, unless circumstances arise that are out of the contractor's control. Notice in writing will be given to the Participating Districts prior to changes that may occur. In the event that the contractor change in pack size impacts the costs of the product for the participated district, the price shall be adjusted accordingly. All packaging shall conform to current standards acceptable to the trade and required by ICC Regulations.

Equivalent Product Approval Request Process

Bidders wishing to offer products equivalent to those identified as "Preferred" must receive approval from the districts in order for the equivalent product to be considered. Products not given a "Preferred" product or manufacturer will be left up to the distributor as to what product they bid as long as it meets the specifications requested. Bidders will have up to ten (10) business days prior to the bid opening to submit for approval.

Alternate Bids

Alternate bids will not be considered unless specifically requested by the provisions of this bid document.

Private Labels on Commercial Products

No private labels will be accepted on commercial products.

Delivery Requirements

The contractor shall make deliveries to all schools in the participating district. A delivery schedule will be agreed upon with the participating districts and the contractor before the contract date starts. The participating district's school information is listed within this document. Please reference this information to determine delivery locations. The delivery times will be conducted between the hours of 6:30am and 2:30 pm. Deliveries made by the Contractor without a scheduled appointment may result in delivery refusal by the district. Any cost accrued as the result of such refusal shall be born solely by the Contractor and not result in any additional costs

to the District. The contractor must be responsible for insuring that delivery personnel remain with their equipment and unload the delivery. Drivers and helpers shall deliver merchandise to designated areas. Drivers and helpers shall request the authorized receiver or the designated representative, to verify the accuracy of quantities of each item, brand and code numbers of each item and condition of merchandise. Each delivery ticket shall be signed by a designated receiver. Variations from the norm, i.e., shortages, damages, etc., shall be noted on each ticket by the designated receiver and initialed by both the truck driver and receiver. The contractor shall not be required to issue credits for errors not detected at the time of delivery, except for hidden damage. The contractor must pick up and credit short dated and out of date items at such times as school officials may reasonably request. The contractor shall deliver goods that have been processed and distributed in accordance with the regulations of the Alabama Department of Public Health and the West Alabama Department of Public Health. All productions must meet standards set by Federal, State and Local Health Departments as to production, processing, purity and approved containers.

Minimum Order

Deliveries are to be made to all schools placing orders provided.

Decimals

Any mathematical calculation that involves decimals shall be treated as follows: All decimals shall be carried only two (2) places in the final extension. Unit price may be extended to four (4) decimal places.

Delivery Delays or shortages

If delivery delays are foreseen Contractor(s) shall notify the Child Nutrition Department of the District, of any shortage(s) three (3) days before the delivery. If deliveries are made wherein shortages or damaged items are noted, the contractor will be required to make "next day" deliveries to correct the discrepancies. However, if the shortage had been noted and transmitted to the affected entity during the order process, the requirement for "next day" shall not apply. The term "next day" is used to allow entities to exercise that option. However, it shall not be intended as mandatory. The successful contractor will pick up damaged or unusable cases of product. The organization will be given credit for all damaged or unusable product. However, the contractor will not be required to credit organizations for damaged product due to TCSS equipment failure.

In the event of default by the Contractor(s) of their obligations, the District reserves the right to obtain the required products elsewhere. The Contractor(s) would be responsible for the District's documented differences in price for the replacement products.

Delivery contact information

Please see the attached sheet.

Substitute Distributor

The term substitute distributor for purposes of this document shall mean the distributor selected to take over the administration of a contract cancelled by the original contractor. The selection of a substitute contractor may result in awarding the contract to the next low responsible bidder based on the bids received when the original award was made or the selection may be made on the basis of a new competitive bid process. If the latter is the case, a bid from the distributor causing cancellation may not be considered.

Fuel Surcharge

In the event that fuel prices increase significantly over the life of the contract, then a fuel surcharge may be negotiated.

Damages

The bidder agrees to be responsible for damage to the milk boxes, refrigerators, building or grounds when such damage was the direct actions of delivery personnel.

Payments

All invoices for products received and accepted prior to the last working day of the month shall be paid on or before the 20th of the next month. Distributor will notify each school district of any delinquencies. One purchase

order will be issued by the Tuscaloosa City Schools and the Tuscaloosa County School System each month for the milk service to all schools served by a vendor.

Delivery Invoices

The contractor must supply two (2) copies of a daily invoice for each delivery to each school. Invoices must include the following information:

- Date of Delivery
- Invoice Number
- Purchase Order Number
- Quantity of Each Item Purchased
- Price of Each Item Purchased
- Extended Total for Each Item
- Grand Total of the Invoice
- Signature of School Personnel

The successful contractor will provide a monthly statement for each school account. This should be a detailed listing of invoices identifying invoice numbers, dates and totals.

The contractor must have a bookkeeper that can assist with resolution of any differences in the accounts. This should be by local telephone.

Taxes

Purchases made under provisions of any contract established as a result of this Invitation are exempt from federal, state and local taxes unless otherwise noted and bidders should quote prices which do not include such taxes.

Gifts, Rebates, Gratuities

Acceptance of gifts from contractors and the offering of gifts by contractors is prohibited. Violations of this provision are punishable under the laws of the State of Alabama.

Cancellation

The participating districts reserve the right to cancel this Request for Bid at any time if cancellation is deemed to be in the District's best interest. In no event shall the district have any liability for the cancellation. The proposer assumes the sole risk and responsibility for all expenses connected with the preparation of its proposal.

Disputes

In case of any doubt or differences of opinions as to the items or services to be furnished hereunder, or the interpretation of the provisions of the Request for Bids, the decision of the participating districts shall be final and binding upon all parties.

Clarification

District reserves the right to request clarification of any item in a firm's proposal or to request additional information necessary to properly evaluate a particular bid. All requests for clarification and responses shall be in writing.

Contractors have the right to request clarification for this bid document. All request shall be made in writing to the Director of Child Nutrition no later than seven (7) working days prior to the time and date set for the bid opening. The Director of Child Nutrition will respond to the request, by letter, or in the form of a written addendum if it is determined that all prospective bidders should have benefit of the clarification. No addendum will be issued within the five (5) day period prior to the date of the bid opening. An addendum may serve to delay that opening for a time sufficient for all bidders to response to the addendum.

Assignment

The contractor shall not assign, or subcontract in whole parts, its rights or obligations under this agreement without prior written consent of the Tuscaloosa County School System. Any attempted assignment or sale of the contract without said consent shall be void and of no effect.

Review and Award

After the public opening of the Request for Bids, school system officials will establish a contract between the lowest responsible, responsive bidder and the school systems on the bid except as may otherwise be specified in the Invitation for Bid. Awards will be based on the total or bottom line on all items listed. Lowest responsible bidder will be determined by the lowest bottom line. Tuscaloosa County Board of Education will serve as the awarding authority based on the following.

1. **Delivery Ability:** Bidder must demonstrate or has demonstrated to the Tuscaloosa County Board of Education the ability to promptly and efficiently deliver all items on the bid list or contract with a 3rd party distributor who has the ability to do so. Telephone numbers should be available in the event of an emergency situation.
2. **Capacity:** Bidder must demonstrate to Tuscaloosa County and City Boards of Education that they have the physical as well as financial capacity to procure and store the merchandise covered by the contract in the volume necessary to efficiently administer the provisions of the contract, or contract with a 3rd party to do so.
3. **Reliability:** For a bidder to be declared a responsible vendor, they must have a proven record of service in the administration of a contract of this size and this type. A distributor may be considered unreliable, thus non-responsible, if for any reasons other than reasons beyond their control, they have violated any of the requirements listed herein or have caused the cancellation of a contract of this type or have failed to properly communicate with participating entities on matters essential to a contract of this type.
4. **Accounting Procedures:** A bidder, to be considered for award, must clearly demonstrate to the Tuscaloosa County Board of Education the capability to provide accurate, reliable and timely invoices, statements, and credits. They must demonstrate the ability and capability to provide any and all date.
5. **Facilities and Equipment:** Bidder must have the warehouse facilities required to safely and securely store the products required by these specifications or contract with a 3rd party to do so. The facilities and operating practices must, at all times, be in compliance with the United States Food, Drug, and Cosmetic Act as well as any State and local Statue, Regulation or Ordinance.
6. **Delivery Equipment:** Bidders must show evidence of ownership or the ability to lease, rent or otherwise obtain vehicular equipment necessary to affect an efficient day to day delivery schedule to participating entities within the bidder's region of responsibility. The Tuscaloosa County Board of Education does not presume to dictate the type of trucks or tractor trucks necessary to accomplish an efficient day to day delivery schedule. However,

bidders should know that all delivery sites do not provide state-of-the-art unloading and food handling facilities. Some sites in fact, fall far short of that standard.

7. Review Process: After bids have been opened and tabulated, the bid evaluation team will check all aspects of the low bidder's proposal. If the proposal is found to be error free and does, in fact, represent the lowest responsible offering, while offering the greatest number of requested items, that bid will then be recommended for approval. If, however, an error is discovered and the error is a mistake in the extension, the correct extension will be applied. Should a corrected extension cause the bid price to be escalated to such an extent that the bid was no longer "low", then the same evaluation would be applied to the next low bidder's offering until a true low bid would be selected.

Bid Acceptance

The Tuscaloosa County Board of Education reserves the right to reject any or all bids, to waive any informality and unless otherwise specified by the bidder, to accept any item on the bid. If a bidder fails to stipulate otherwise, it is understood and agreed that the Tuscaloosa County Board of Education has sixty (60) days to accept. The Tuscaloosa County Board of Education is awarding authority for all systems listed in this document and reserves the right to reject any and all bids.

Termination of Contract

Failure on the part of the participating school systems or the contractor to meet requirements as stipulated of this contract may result in contract termination.

- A. Each party shall follow the procedure outlines below if a contract is to be terminated. All transactions shall be sent by Registered or Certified mail.
Step 1: Verbal communication in regards to violation.
Step 2: Issue warning letter and outline violations and length of time to correct the problem.
Step 3: Issue letter of Intent to Cancel Contract if problem is not resolved by given date.
Step 4: Issue letter to cancel contract.
- B. In the event that the physical facilities of the contractor are destroyed, the contractor will not be held liable by the participating school systems. The contractor may not be held liable for the terms of the contract should normal fulfillment of the contract be disrupted by an organized labor strike. The credibility of any such labor disruption claim should be verified by the participating school system before allowing the termination of the contract.

Federal Requirements

- A. The District participates in the National School Lunch Program and School Breakfast Program and is required by law to use school foodservice funds, to the maximum extent practical, to buy domestic commodities or products for meals served under these programs. A "domestic commodity or product" is defined as one that is either produced in the U.S. or is processed in the U.S. substantially using agricultural commodities that are produced in the U.S. The term "substantially" means that over 51 percent of the final processed product consists of agricultural commodities that were grown domestically. PART 210-NATIONAL SCHOOL LUNCH PROGRAM

Subpart c - Requirements for School Food Authority Participation §210.16 Food service management companies

(d) Duration of contract. The contract between a school food authority and food service management company shall be of a duration of no longer than 1 year; and options for the yearly renewal of a contract signed after February 16, 1988, may not exceed 4 additional year. All contracts shall include a termination clause whereby either party may cancel for cause with 60-day notification.

Subpart E-State Agency and School Food Authority Responsibilities §210.21 Procurement.

(d) Buy American-

- (1) Definition of domestic commodity or product. In this paragraph (d), the term 'domestic commodity or product' means-
 - (i) An agricultural commodity that is produced in the United States; and
 - (ii) A food product that is processed in the United States substantially using agricultural commodities that are produced in the United States.
- (2) Requirement.

(i) In general. Subject to paragraph (d)(2)(i) of this section, the Department shall require that a school food authority purchase, to the maximum extent practicable, domestic commodities or products.

(ii) Limitations. Paragraph (d)(2)(i) of this section shall apply only to-

(A) A school food authority located in the contiguous United States; and

(B) A purchase of domestic commodity or product for the school lunch program under this part.

(f) Cost reimbursable contracts-

(1) Required provisions. The school food authority must include the following provisions in all cost reimbursable contracts, including contracts with cost reimbursable provisions, and in solicitation documents prepared to obtain offers for such contracts:

(i) Allowable costs will be paid from the nonprofit school food service account to the contractor net of all discounts, rebates and other applicable credits accruing to or received by the contractor or any assignee under the contract, to the extent those credits are allocable to the allowable portion of the costs billed to the school food authority;

(ii) (A) The contractor must separately identify for each cost submitted for payment to the school food authority the amount of that cost that is allowable (can be paid from the nonprofit school food service account) and the amount that is unallowable (cannot be paid from the nonprofit school food service account); or

(B) The contractor must exclude all unallowable costs from its billing documents and certify that only allowable costs are submitted for payment and records have been established that maintain the visibility of unallowable costs, including directly associated costs in a manner suitable for contract cost determination and verification;

(iii) The contractor's determination of its allowable costs must be made in compliance with the applicable Departmental and Program regulations and Office of Management and Budget cost circulars;

(iv) The contractor must identify the amount of each discount, rebate and other applicable credit on bills and invoices presented to the school food authority for payment and individually identify the amount as a discount, rebate, or in the case of other applicable credits, the nature of the credit. If approved by the State agency, the school food authority may permit the contractor to report this information on a less frequent basis than monthly, but no less frequently than annually;

(v) The contractor must identify the method by which it will report discounts, rebates and other applicable credits allocable to the contract that are not reported prior to conclusion of the contract; and

(vi) The contractor must maintain documentation of costs and discounts, rebates and other applicable credits, and must furnish such documentation upon request to the school food authority, the State agency, or the Department.

(2) Prohibited expenditures. No expenditure may be made from the nonprofit school food service account for any cost resulting from a cost reimbursable contract that fails to include the requirements of this section, nor may any expenditure be made from the nonprofit school food service account that permits or results in the contractor receiving payments in excess of the contractor's actual, net allowable costs.

(g) Geographic preference.

(1) A school food authority participating in the Program, as well as State agencies making purchases on behalf of such school food authorities, may apply a geographic preference when procuring unprocessed locally grown or locally raised agricultural products. When utilizing the geographic preference to procure such products, the school food authority making the purchase or the State agency making purchases on behalf of such school food authorities have the discretion to determine the local area to which the geographic preference option will be applied;

(2) For the purpose of applying the optional geographic procurement preference in paragraph (g)(1) of this section, "unprocessed locally grown or locally raised agricultural products" means only those agricultural products that retain their inherent character. The effects of the following food handling and preservation

techniques shall not be considered as changing an agricultural product into a product of a different kind or character: Cooling; refrigerating; freezing; size adjustment made by peeling, slicing, dicing, cutting, chopping, shucking, and grinding; forming ground products into patties without any additives or fillers; drying/dehydration; washing; packaging (such as placing eggs in cartons), vacuum packing and bagging (such as placing vegetables in bags or combining two or more types of vegetables or fruits in a single package); the addition of ascorbic acid or other preservatives to prevent oxidation of produce; butchering livestock and poultry; cleaning fish; and the pasteurization of milk.
