## **Arvada High School Automobile Parking Contract**

Jefferson County School District requires that any vehicle that is to be parked in any JeffCo lot be registered with the school. Arvada High School follows those same guidelines and requires registration with our Security Department and to hang your pass from your rear view mirror at all times. Vehicles that are not registered or parked in the incorrect lot, will be subject to a fine and /or towing at any time, at the owner's expense.

### **Parking Permit Rules**

1. Proof of Driver's license must be shown to obtain a parking pass.
2. A current valid Arvada High School permit must be displayed and clearly visible from the front of the vehicle.
3. The vehicle must be operated in a safe and lawful manner on school grounds and streets bordering the campus.
4. Parking spaces are reserved for cars displaying permits from 7:00am-3:00pm on school days. After 3:00pm, lots are open.
5. Remaining in parked vehicles or loitering in the lots is not permitted.
6. The bus lane is for immediate pickup or drop off of passengers. They driver is not to leave the vehicle unattended at any time.
7. Vehicles are towed at the owner's expense and without notice.
8. Any violations of any kind will result in the revocation of the student's parking permit for the remainder of the school year.
9. AHS reserves the right to revoke any student parking privileges for any violations of school policy on or off of school property and any bordering streets.
10. There will be a \$5 fee to replace lost parking permits.
