Re-Enrollment Down Payment	· 2500 MAD for each child re-enrolling, payment due before May 15, 2024. (Refundable until July 1, 2024) (The deposit will be deducted from the total invoice balance.)
Option 1	· Complete full payment (100%) before August 15, 2024.
Option 2	· Complete the first tuition installment (50%) before August 15, 2024. · Complete the second tuition installment (50%) by December 4, 2024.
Option 3	· Complete the first tuition installment (1/3) before August 15, 2024. · Complete the second tuition installment (1/3) by December 4, 2024. · Complete the third and last tuition installment (1/3) by March 15, 2025.
Option 4	· Complete the tuition in 10 equal, monthly payments starting August 15, 2024, and to be completed before the end of May 2025 under a signed and notarized payment plan.

Means of payment

- **Payment in cash:** Deposit must be made directly in the school bank account: *Bank of Africa, Rue Irak Bd. Ibn Tachfine, Tangier*. The bank deposit slip must be presented to the Business Office to justify the payment and to get the payment receipt.
- **Payment by checks:** Checks must be payable to **THE AMERICAN SCHOOL OF TANGIER**.
- **Payment by bankcard (TPE).**

Refund Policy

The school does not refund tuition fees due to suspension, expulsion or mandated or voluntary withdrawal of a student for disciplinary reasons. Partial refunds may be awarded if the withdrawal is not related to disciplinary problems and is clearly due to reasons beyond the parents' control. However, fees related to a started quarter will not be refunded.
