PROPOSITION NO. 1 – 2024-2025 BUDGET

RESOLVED, that the Board of Education of the Clarkstown Central School District, in the County of Rockland, New York, be authorized to expend an amount not to exceed \$253,179,418 during the 2024-2025 school year and to levy the tax necessary therefor; and BE IT FURTHER RESOLVED, that the Board of Education of the Clarkstown Central School District is authorized to expend the costs incidental thereto, for floor tile replacement and abatement at Felix Festa Middle School, the amount of \$4,500,000, which amount is PART OF AND NOT IN ADDITION TO THE PROPOSED BUDGET SET FORTH ABOVE.

PROPOSITION NO. 2 – CAPITAL RESERVE FUND EXPENDITURE

RESOLVED, that the Board of Education of the Clarkstown Central School District is authorized to expend \$1,198,604 out of the School District's Capital Reserve Fund 2018 and to expend \$817,461 out of the School District's Capital Reserve Fund 2020 to fund the balance of floor tile replacement and abatement at Felix Festa Middle School and to replace the Safety-Security Public Announcement (PA) Systems at Clarkstown High School North and Clarkstown High School South. Funds will be withdrawn from the School District's existing Capital Reserve Fund 2018 and Capital Reserve Fund 2020 AND WILL NOT RESULT IN AN INCREASE IN THE TAX LEVY.
