Nurse countered with the pricing being higher to purchase Elena explains that the cost has to maintain to cover our cost from our vendors Shelley explained they could buy items from "sams" as long as it still qualified as smart snack compliant. Like the ones we sell in snack bars. Only exception to the rule is to fill out the exception form by principle for ADE approval Vista team agreed with understanding

Under the competitive foods and beverages paragraph a change needs to be made to take out student nutrition director as approver.

VHS Student and Nurse asked if there could be more snacks and variety added to their snack bar as they have very little or none at all.

Shelley said she could arrange that.

VHS Students and nurse talked about vending machines and who is in charge of it and how they can get one to help with VHS needs to have options other than milk and juice.

Shelley explained that SNS is not in charge of those usually as a group like student cancel and that they still would only be compliant items that would not be able to be served during serving times. Shelley offered to share vendor information for vending machines

Hildreth mentions that vending machines are a huge responsibility and accountability.
