### DISCUSSION

- 5. Superintendent's Report
  - 5.1. Dr. Sever invited the Board to attend the Fresno County Educator of the Year Awards Ceremony, where our 22-23 employees of the year- Sarah Schmal (KECSD Teacher of the Year), Roberto Vega-Montoya (KECSD Classified Employee of the Year), and Amy Winchell (KECSD Administrator of the Year) will be honored. The event will take place Thursday, November 30, 2023, at the William Saroyan Theatre from 7:00 to 9:30 pm. You do not need

tickets to attend. Again, we congratulate Sarah, Roberto, and Amy for their commitment to our students and for representing Kingsburg Elementary Charter School District on November 30th!

- 5.2. The annual 212 Degree Presentations recently concluded. These presentations are opportunities for principals to present their current levels of achievement and what they will do to improve this year. 212 Degrees Presentations allow the District Office and district support members to better understand the needs, goals, programs, and direction of all schools. The presentations allow a dialogue between the principal and their peers, allowing all participants to grow and improve for the benefit of students. Each school presentation was shared with the Board.
- 5.3. Dr. Sever reported on the recent ACSA Leadership Summit conference he attended.
- 5.4. Mr. Stovall did a great job organizing the November 1st PD Day for staff. We had a lot of positive feedback from staff.
- 5.5. The KECSD School Calendar vote for 24-25 and 25-26 school calendars has begun and will run through November 30th. The Board will approve the chosen calendar at the December meeting.
- 5.6. We want to congratulate Lincoln School Principal Lauren Galli, who has been nominated and selected as one of the members of Business Street's "40 Under 40" Class of 2023, recognizing her outstanding contributions and achievements in education. The "40 Under 40" Class of 2023 award ceremony will be held on Thursday, December 7th, 2023, at 6:00 pm, at Chukchansi Park.
- 5.7. Students from Beyond the Bell went to the Monterey Bay Aquarium recently. For some of the 115 students, it was their first time seeing the ocean. Thank you to the Pantages family for arranging the free tickets to the aquarium through the Free to Learn Program, and thank you to David Silva for donating the fruit for the meals. Thank you to Mrs. North for organizing this successful trip.
- 5.8. At the last meeting, the Board had asked for more detailed information on Raising Highly Capable Kids, the parenting classes that the Community Schools department runs. Information provided by Mrs. Simmons was shared with the Board.
- 6. Assistant Superintendent's Report
  - 6.1. Bilingual Night is scheduled for November 28th at Reagan Elementary, beginning with dinner at 5 pm. The keynote speakers for the evening will be the McFarland Track Team. We will recognize and honor 70 students who will be redesignated and present them with achievement awards.
  - 6.2. The book chosen for this year's Kingsburg Reads One Book Program is "The One and Only Ivan." Clay School will be participating again this year. The kickoff week is February 26th. The reading will begin on March 4th and end on March 21st.
  - 6.3. The November 1 PD Day went very well, and we received a lot of positive feedback from staff. Mr. Stovall shared pictures and highlighted some thoughtful messages he received from staff.
- 7. Chief Business Official's Report
  - 7.1. The recent Taste of KECSD event was well attended by about 60 people. Families were able to taste test different foods we serve as well as those we may add and also take food home. Many vendors were there, as well as our food service director and staff. Prizes were given out, and families enjoyed the time there. We will continue with this each year and look at other convenient times for families.
  - 7.2. The MOT department recently helped update the 3D printing station at Rafer Johnson Jr. High in Mr. Manuszak's class. It's something that has been needed for a while. It looks great, and students are excited to use the new station. Thank you to Mr. McIntyre for designing the station and the MOT crew for installing it.
  - 7.3. Our District Wellness Committee Meeting took place in October. We are looking at ways to get the whole staff involved in wellness. A step challenge is one option, and we are figuring out

the details of possibly starting in January. We would break schools and staff up into equal teams. We are looking at more community and fun among our staff, and this could be a fun way to bring people together.

- 7.4. The deadline for CA taxes was extended from October 16th to November 16th. As of October 16th, of the \$42 billion they anticipated in October, only \$18 billion came in. The Governor is coming out with his 24-25 budget in January. November 16th will be the final deadline for taxes, and the numbers we see by December 1 will play a huge role in what our plans are going forward. The delayed tax deadline has made it very difficult to plan, as we don't know the numbers for the out years. We will wait until the tax receipts come in before making any financial recommendations to the Board. The business office will attend several meetings with companies that analyze the budget and the Governor's proposal to make a recommendation regarding any salary increases. We will do what's best for the district in the long run.
