What is the overall deductible?	\$1,000 member/ \$3,000 family Benefits are administered on a Plan Year basis.	Generally you must pay all the costs up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, they have to meet their own individual <u>deductible</u> until the overall family <u>deductible</u> amount has been met.
Are there services covered before you meet your <u>deductible</u> ?	Yes: Preventive care, prescription drugs, provider office visits, services from Select LP Providers, emergency room care, outpatient mental health services, habilitation services, rehabilitation services, routine eye exams, are covered before you meet your deductible.	This plan covers some items and services even if you haven't yet met the deductible amount. But, a copayment or coinsurance may apply. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limit</u> until the overall family <u>out-of-pocket limit</u> has been met.
