Voter Qualifications for May 16 Budget Vote

- * Citizen of the United States;
- * At least 18 years old;
- * District resident for at least 30 days just prior to the vote:
- * Must be eligible under Section 5-106 of the Election Law;
- * No pre-registration required.

Note: Individuals who are first-time voters should be prepared to provide identification to the poll inspector at the time of voting.

PROPOSITION NO. 1 ENTIRE EDUCATIONAL PROGRAM BUDGET 2023-2024

Shall the following resolution be adopted, to wit:

RESOLVED, that the budget for the Iroquois Central School District, Erie County (the "District") for the fiscal year commencing July 1, 2023, as presented by the Board of Education, is hereby approved and adopted, in an amount not to exceed \$56,898,897 and the required funds therefore are hereby appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in said District to be levied and collected as required by law.



PROPOSITION NO. 2 PURCHASE OF PUPIL TRANSPORTATION VEHICLES

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the Iroquois Central School District (the "District") is hereby authorized to undertake the acquisition of four diesel fuel 63 -passenger buses (at a maximum average cost of \$160,788 each), and one gasoline fuel 30-passenger, wheelchair equipped bus (at a maximum estimated cost of \$90,224 each) for use in the transportation program of the District, and having an estimated maximum aggregate cost of \$733,378, less trade-in value, if any; and that such aggregate sum (or so much thereof as may be necessary) shall be raised by the levy of a tax to be collected in annual installments, with such tax to be partially offset



by state transportation aid available and received therefore; and, in anticipation of such tax, debt obligations of the District shall be issued in an amount not to exceed \$733,378, or the District may enter into a lease/purchase or installment purchase contract up to such stated amount (and having a term of not more than five years), if the Board of Education determines that it is in the best interest of the District to finance the purchases using that method.


PROPOSITION NO. 3 FUNDING THE REPAIR RESERVE

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the Iroquois Central School District, Erie County, is hereby authorized, to transfer an amount not to exceed \$450,000 from future unappropriated fund balance of the District to the Repair Reserve Fund (created by Board Resolution on July 6, 2022). The Reserve is to be used for repairs to capital improvements and/or equipment as authorized by General Municipal Law Section 6-d.

Understanding Your School Taxes

Three Factors That Affect Your Tax Rate

- 1. The **Tax Levy** from the school district.
 - From the budget approved by district voters;
 - Set by district voters at the May budget vote.
- 2. The **Equalization Rate** set by New York State.
 - New York State balancing property values in the different townships;
 - The lower the equalization rate, the higher the full value and the higher your tax rate;
 - Fixed in <u>August</u> by New York State Property Tax Division.
- 3. The **Total Assessed Value of the District** set by the Tax Assessors of the towns.
 - Home values and new construction;
 - ◆ The more improvements to the entire community, the higher the assessed value and the lower the tax rate;
 - Set by Town Assessors in June;
 - ◆ Individual households value changes from improvements and similar house sales.


Approximately three years ago, teachers and administrators began studying the Science of Reading. The research has been available for several years and continues to be transformed into practice. It centers on the key aspects of how students learn to read and comprehend. This is no small feat.

This year, our focus is to strengthen our phonemic and phonics curriculum and instruction. To accomplish this,

we partnered with the REED Charitable Foundation for training. All K-2

classroom teachers, and K-4 Special Education and RtI teachers received 30 hours of training in Orton-Gillingham, phonics, and phonemic awareness. This highly researched methodology provides the foundation for our early readers.

Additionally, and with the help of our 2 Literacy TOSAs [teachers on special assignment], professional development in reading is extending through our entire K-12 grade levels. Faculty are expanding



Our goal is to continue our study in the elements of the Science of Reading and make modifications to curriculum and instruction that will strengthen our students' ability to read and comprehend earlier and with various modes of medium. To do this, all involved continue to model the commitment to be life-long learners and good role models for our students.



Message from the Superintendent

I would like to thank everyone, including students, parents, faculty, staff, administration, and the community for their continued support for student instruction. The world today presents unique challenges, and the Iroquois community continually responds in a united fashion through collaboration, which is what makes Iroquois so great. Student instruction and safety continues to be at one of the highest levels in Western New York and New York State.

This accomplishment exemplifies the statement "Iroquois is a family" which puts students first to overcome any obstacle. It also highlights our continuing focus on the future, balancing instruction for students while mindful of the fiscal impact on the community. Iroquois will continue this balance with the 2023-24 school budget enabling us to maintain the current programs and services for students.

This year was the first year with School Resource Officers in all buildings. This additional safety measure was a great success. The officers are continually present in the buildings and implemented numerous changes to practice which provide greater safety. One example is that meetings were held in all buildings to gather teacher and staff feed-

back to determine what procedures required modification.

The Strategic Plan moves forward in its first year with three main areas of focus: Communication, Student Experience, and Facilities. A new communication system was implemented that provides accurate, timely and meaningful information at all levels to all stakeholder groups. Additionally, Iroquois will again survey those at every level of the District to provide feedback on areas of success and areas in need of improvement. Student Experience focuses on a goal of achieving 100% of our K-12 students having access to a high quality Multi-Tiered System of Supports (MTSS) for both academic and social emotional learning. Additionally, we will focus on students developing leadership aptitudes, advocacy skills, and community involvement expertise to meet the needs of their future professions. A Facilities committee is focusing on the development and implementation of an action plan. This will be based on a critical analysis of all structures and spaces District-wide to determine what is in the best interest of teaching and learning, while protecting the investments of the community.

The annual school budget vote and Board of Education election will take place on May 16th from 7:30 am through 9:00 pm in the Intermediate Gymnasium. If you have concerns with voting in person, please contact the District Clerk to obtain an absentee ballot. Questions & Answers

Q: Has the Board of Education initiated any new future focused planning?

A: Yes. The Iroquois Board of Education is in its first year of a five-year Strategic Plan developed by members of the community, students, staff, teachers, and administration. This process reflects current practices and goals for creating a comprehensive plan for the future.

Q: Did the Iroquois School District remain within the tax cap limit?

A: Yes. Iroquois has remained within the tax cap every year since its inception and is doing so again for the 2023-2024 school budget.

Q: Does the increase in the tax levy actually equal the increase on my school tax bill?

A: No. There are additional factors, such as equalization rate and assessment, that cause the individualization of each resident's tax bill.

O: How are the reserves funded?

A: After all expenditures are complete, the remaining balance is used to fund reserves.

Q: What is a repair reserve?

A: The funds in a repair reserve are only allowed to be used to fix an unanticipated equipment or infrastructure failure. The fund will be funded by unrealized expenditures during a school year.

Questions & Answers cont.

Q: With the change in enrollment, has the District reduced staff?

A: Yes. Annually the District reviews the staff/enrollment ratio to adjust for changes in enrollment. This year there will be an adjustment of approximately 5%. In the previous ten years, the district has reduced general education staff by 15% and administration by 5%.

Q: Has the District implemented any new practice to make budget information more available to community members?

A: Yes. The District has implemented a new communication service that allows any resident to sign up and receive texts, emails and phone calls directly from the school which may include budget information, newsletters and mailings. The link to sign up is on the website, www.iroquoiscsd.org, under *Announcements*.

Q: What methods does the Iroquois Board of Education use to hear public opinion?

A: The Board of Education uses multiple methods to listen to the public as a whole. There is time devoted at every Board meeting to listen to the public directly. In addition, the email addresses of all board members are posted on the District website and a community roundtable takes place every year.

Q: What happens if the May 16th budget vote is not supported?

A: If the budget is not supported the Board of Education will decide to either:

- Return to voters with reduced athletic and extracurricular club expenditures, decreased course offerings and increase class size; or,
- Return to the voters with the same proposed budget and corresponding tax levy; or,
- Adopt a contingent budget.

Q: What does it mean if the budget is defeated, and we are required to adopt a contingent budget?

A. A contingency budget would cause elementary class sizes, in a majority of the classes, to increase to approximately 27 students per class. There would be a reduction of elective courses, including art and music, as well as advanced placement courses. It would also be necessary to eliminate some modified, junior varsity and varsity sport teams, as well as some extracurricular clubs. Equipment purchases would be eliminated. In addition, all non-school organizations would be required, by law, to pay for the use of school building facilities.
