- * District resident for at least 30 days just prior to the vote:
- * Must be eligible under Section 5-106 of the Election Law;
- * No pre-registration required.

Note: Individuals who are first-time voters should be prepared to provide identification to the poll inspector at the time of voting.

PROPOSITION NO. 1 ENTIRE EDUCATIONAL PROGRAM BUDGET 2022-2023



Shall the following resolution be adopted, to wit:

RESOLVED, that the budget for the Iroquois Central School District, Erie County (the "District") for the fiscal year commencing July 1, 2022, as presented by the Board of Education, is hereby approved and adopted, in an amount not to exceed \$54,984,552 and the required funds therefore are hereby appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in said District to be levied and collected as required by law.

PROPOSITION NO. 2 PURCHASE OF PUPIL TRANSPORTATION VEHICLES

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the Iroquois Central School District (the "District") is hereby authorized to undertake the acquisition of three diesel fuel 63-passenger buses (at a maximum average cost of \$131,890 each), and one cutaway bus (at a maximum estimated cost of \$78,500 each) for use in the transportation program of the District, and having an estimated maximum aggregate cost of \$474,169, less trade-in value, if any; and that such aggregate sum (or so much thereof as may

be necessary) shall be raised by the levy of a tax to be collected in annual installments, with such tax to be partially offset by state transportation aid available and received therefore; and, in anticipation of such tax, debt obligations of the District shall be issued in an amount not to exceed \$474,169, or the District may enter into a lease/purchase or installment purchase contract up to such stated amount (and having a term of not more than five years), if the Board of Education determines that it is in the best interest of the District to finance the purchases using that method.

PROPOSITION NO. 3 PROPERTY ACQUISITION: ELMA FIRE SUBSTATION

Shall the following resolution be adopted, to wit:



RESOLVED, that the Board of Education (the "Board") of the Iroquois Central School District, Erie and Wyoming Counties, New York (the "District") is hereby authorized to purchase a parcel of real property commonly known as 2070 Girdle Road, Elma, New York, SBL No. 138.03-7-30 for the price of \$470,000, subject to certain conditions set forth in the purchase contract between the parties, and upon such other terms and conditions as the Board shall deem appropriate, with such expenditures to be made from available funds of the District, without the necessity of borrowing.

PROPOSITION NO. 4 AT-LARGE VOTING FOR MEMBERS OF THE BOARD OF EDUCATION


Shall the following resolutions be adopted, to wit:

RESOLVED, that commencing on or after May 18, 2022, and at all subsequent elections held to fill vacancies on the Board of Education, vacancies upon the Board of Education shall not be considered separate specific offices and that the nominating petitions shall not describe any specific vacancy upon the Board of Education for which the candidate is nominated.

BE IT FURTHER RESOLVED, that consistent with New York Education Law §2018(b), this at-large voting process shall continue until repealed by the electors of the district at a regular election by the adoption of a proposition to repeal the same.

Understanding Your School Taxes

Three Factors That Affect Your Tax Rate

- 1. The **Tax Levy** from the school district.
 - From the budget approved by district voters;
 - Set by district voters at the May budget vote.
- 2. The **Equalization Rate** set by New York State.
 - ♦ New York State balancing property values in the different townships;
 - ◆ The lower the equalization rate, the higher the full value and the higher your tax rate;
 - Fixed in August by New York State Property Tax Division.
- 3. The **Total Assessed Value of the District** set by the Tax Assessors of the towns.
 - Home values and new construction;
 - ◆ The more improvements to the entire community, the higher the assessed value and the lower the tax rate;
 - Set by Town Assessors in June;
 - ♦ Individual households value changes from improvements and similar house sales.



Message from the Superintendent

To the joy of everyone the 2021-22 school year started with the return of 100% in-person instruction. As the year continued, Iroquois persevered through the many challenges of the pandemic. I would like to thank everyone, including students, parents, faculty, staff, administration, and the community for their continued support for student instruction. COVID presented unique challenges, but the Iroquois community responded in the unified fashion that makes Iroquois so great. Student instruction continued at one of highest levels in WNY and NYS. This accomplishment exemplifies the statement that "Iroquois is a family" that puts students first to overcome any obstacle. It also highlights our continuing focus on the future, balancing instruction for students while mindful of the fiscal impact on the community. Iroquois will continue this balance with the 2022-23 school budget enabling us to continue maintaining the current programs and services for the students in addition to the new Strategic Plan that has been developed and adopted by

the Board of Education this year.

The Strategic Plan contains three main areas of focus: Communication, Student Experience, and Facilities. Communication will focus on providing accurate, timely and meaningful information at all levels to all stakeholder groups. This will include every level of the District with continual surveys to provide feedback on areas of success and areas in need of improvement. Student Experience focuses on achieving 100% of our K-12 students having access to a high quality Multi-Tiered System of supports for both academic and social emotional learning. Additionally, Iroquois will focus on having students develop leadership aptitudes, advocacy skills, and community involvement expertise to meet the needs of their future professions. Facilities focuses on developing and implementing an action plan based on a critical analysis of all structures and spaces district-wide to determine what is in the best interest of teaching and learning as well as protecting the investments of the community.

The annual school budget vote and Board of Education election will take place on May 17th from 7:30 am through 9:00 pm in the Intermediate Gymnasium. Questions & Answers

Q: Has the Board of Education initiated any new future focused planning?

A: Yes. The Iroquois Board of Education adopted a Strategic Plan developed by members of the community, students, staff, teachers and administration. This process reflects on current practices and goals to create a comprehensive plan for the future.

Q: How will Purchasing the firehall benefit the District?

A: It will provide both short- and long-term instructional and fiscal benefits to students and the community. Some of these include: replacement of temporary structures from the 1960's, increased instruction space by the relocation of back-office operations, centralization and increased efficiency of Building and Grounds, reduced future capital project costs, increased maintenance and care of equipment, space for transportation requirements and future instructional space opportunities.

Q: Does this purchase save expenditures for future capital projects?

A: Yes, based on the 2019 NYS Building Condition Survey, there is over \$1.4 million in reduction of future capital projects by the purchase due to the immediate replacement of the temporary structures built in the 1960s.

Q: What is the funding source to purchase the firehall?

A: The funds will be transferred from allotments that would otherwise be directed to the capital reserve. The reduction in future capital project expenditures allows for the modification in long-range planning.

Q: Is the property adjacent to current District property?

A: Yes, the District owns the property directly to the south.

Ouestions & Answers cont.

Q: Has the current real estate market impacted the purchase price of the property?

A: No, the negotiated price has remained the same even though market prices have increased. It is important to note that if the District was to construct the same building the cost would be more than double the purchase price.

Q: Did the Iroquois School District remain within the tax cap limit?

A: Yes. Iroquois has remained within the tax cap every year since its inception and is doing so again for the 2022-2023 school budget.

Q: Does the increase in the tax levy actually equal the increase on my school tax bill?

A: No. There are additional factors, such as equalization rate and assessment, that cause the individualization of each resident's tax bill.

Q: How are reserves funded?

A. After all expenditures are complete, the remaining balance is used to fund reserves.

Q: Is the total dollar amount stated in the bus purchase proposition the actual amount expended?

A. No, by law we must state the maximum cost, but we always trade in buses which reduces the final cost of the buses purchased.

Q: With the change in enrollment, has the District reduced staff?

A: Yes. Annually the District reviews the staff/enrollment ratio to adjust for changes in enrollment. In the last ten years, the district has reduced general education staff by 15% and administration by 5%.

Q: Has the District implemented any new practice to make budget information more available to community members?

A: Yes. The District has implemented an email service that allows any resident to sign up and receive emails directly from the school which include budget information, newsletters and mailings. The link to sign up is on the website, www.iroquoiscsd.org, under *Announcements*.

O: What methods does the Iroquois Board of Education use to hear public opinion?

A: The Board of Education uses multiple methods to hear the public as a whole. There is time devoted at every meeting to listen to the public directly. In addition, the email addresses of all board members are posted on the district website and a community roundtable takes place every year.

Q: What happens if the May 17th budget vote is not supported?

A: If the budget is not supported, on May 18th, the Board of Education will decide to either:

- Return to voters with reduced athletic and extracurricular club expenditures, decreased course offerings and increase class size; or,
- Return to the voters with the same proposed budget and corresponding tax levy; or,
- Adopt a contingent budget.

Q: What does it mean if the budget is defeated and we are required to adopt a contingent budget?

A: A contingent budget would cause elementary class sizes, in a majority of the classes, to increase up to approximately 27 students per class. There would be a reduction of elective courses, including art and music, as well as advanced placement courses. It would also be necessary to eliminate some modified, junior varsity and varsity sport teams, as well as some extracurricular clubs. Equipment purchases would be eliminated. In addition, all non-school organizations would be required, by law, to pay for the use of school building facilities.
