This was a group of pilots that fought in WWII. He explained that these airmen had to fight two wars. They had to fight the war of racism and segregation just to have the right to fly. After fighting the racism fight then they got to fight in WWII. Most of the airmen are now deceased. They did a wonderful job. Most of President Griffin's family is from Tuskegee and he mentioned Tuskegee Field where much of the training was done. One of the Tuskegee airmen was a San Mateo High School graduate named Les Williams. He was the first bomber pilot they had and was a Captain in the Army . He graduated with President Griffin's mother pre-war from San Mateo High School. He came back after the war and taught tap and jazz dance on San Mateo Avenue and he was a lawyer. He wanted to take this time to recognize him for his accomplishments.
