## **JOB SUMMARY:**

Under the general supervision of the site administration the Dean of Students is responsible for general discipline and supervision of students.

#### **ESSENTIAL FUNCTIONS:**

- 1. The identification, intervention, and case management of students demonstrating mild to critical at-risk behaviors
- 2. Instituting and maintaining liaison activities for parents, police, probation, medical and health agencies
- 3. General student discipline, behavior, and attendance
- 4. Campus security and supervision of campus aides
- 5. Student activities supervision
- 6. Transportation and traffic control supervision
- 7. Service Commission supervision
- 8. Communication with parents regarding discipline and attendance
