#### **Job Summary:**

• Under the direction of the Manager of Multilingual Learners, the Multilingual Learner (ML) Independent Study Teacher position provides alternative instruction, outside of the regular classroom setting, for ML students to meet graduation requirements.

# **Job Essential Functions:**

- Provides direct instruction, in person and virtually, for students enrolled in ML Independent Study.
- Uses district approved learning platform to deliver content classes.
- Adapts teaching methods, differentiates instruction and utilizes appropriate materials to meet students' identified needs.
- Supervises, facilitates and supports students to complete courses successfully.
- Maintains records of student assignments showing the date the assignment is given and the date the assignment is due, progress and final grade.
- Evaluates student progress on a regular basis and revises individual instructional plans as appropriate in collaboration with the students' counselor.
- Regularly meets with students to discuss progress and counsel as necessary for individual student success.
- Maintains a daily or hourly attendance records including class attendance and work completion records.
- Maintains any other required records and files on a current basis.
- Establishes and maintains standards and procedures which promote an effective and positive learning environment.
- Implements a program that provides continuity and consistency for students.
- Utilizes strategies to promote in students a positive self-concept, self-awareness, self-discipline, responsibility and respect for others.
- Maintains a proactive and positive relationship with students, staff, parents and community members.
- Follows district processes for Independent Study, including the Independent Study Master Agreement (BP 6158).
- Performs other related duties as assigned.
