## **Letter From COC Chair**

- Citizen's Oversight Committee (COC) for Bond Measures M (2006)
   & O (2010)
- Met 4 times during the fiscal year to review Financial Reports, project expenditure summaries, project accomplishments/challenges/legal hurdles
- Measure M funded major construction programs including all theaters, at all comprehensive High Schools, all of which are completed
- Measure O funds were used to complete the project list, projects include the new science building at Hillsdale High School, new building at Burlingame High School, stadium sound systems and lights, nearly completed District Office and future Peninsula High School

## **Accomplishments:**

- Recommended Deferred Maintenance Sinking Fund
- Operations and Maintenance staffing adequate to clean facilities

#### **Concerns:**

- The COC appreciated the Board of Trustees consideration of another bond measure. The COC unanimously supported the District pursuing another capital facilities bond so long as the proceeds would be used for safety, sustainability and technology projects.
- The COC understand the reason the Board of Trustees chose not to move forward and place a bond on the 2018 ballot. The COC wants to encourage the Board of Trustees to follow through with their commitment of placing another bond on the 2020 ballot.
- The COC is deeply troubled with the safety and health of the transite panels (HHS, AHS, MHS). These panels contain asbestos and are over 60 years old. They are deteriorating rapidly and there is a possibility rodents could spread asbestos.
- Just under \$2 million is remaining in Measure M funds and could be applied to mitigate the worst asbestos panels.

#### **Concerns:**

- When the COC raised the concern about their concern about the transite panels in 2009, the cost to mitigate the problem was \$15M. Due to the change with Building codes and construction escalation, the same project is anticipated to cost \$65M.
- The COC would like the Board of Trustees to conduct environmental testing on the panels manufactured with asbestos.



## Health and Safety

Asbestos (Transite) panel mitigation and/or replacement

- -- 60+ year old panels are deteriorating
- -- Rodents are possibly spreading asbestos

## **Adequate Facilities Staffing:**

- Capital Facilities Bond Measures:
  - o Measure D (2000) is 18 years old
  - o Measure M (2006) is 12 years old
  - o Measure O (2010) is 8 years old
- 350,000 square feet of NEW facilities have been constructed and 844,500 square feet of facilities has been modernized, with fewer maintenance staff.
- Facilities are technologically sophisticated with complex systems that require highly skilled staff to operate and maintain.

## **Letter From COC Chair (cont'd): Conclusion**

- Measures M and O are fiscally sound.
- All expenditures are compliant with Proposition 39, Article XIIIA, Section 1(b)(3) of the California Constitution as applicable to the approved construction projects.

## **Bond Overview – Measure M**

- Measure M is a Proposition 39 bond initiative and required 55% approval by registered voters in the District.
- The purpose of Measure M is to implement the Capital Facilities Plan to renovate, remodel and expand the existing school facilities to provide safe, healthy and state-of-the-art teaching facilities for academic success.
- On November 7, 2006, the voters of San Mateo Union High School District approved Measure M and an extensive list of projects by a Yes vote of 66.5%.

## **Bond Overview – Measure O**

- Measure O is a Proposition 39 bond initiative and required 55% approval by registered voters in the District.
- The purpose of Measure O is to complete the Board approved Capital Facilities Plan.
- On November 2, 2010, the voters of San Mateo Union High School District approved Measure O and an extensive list of projects by a Yes vote of 61.9%

## **Proposition 39 Requirements**

- A list of projects was provided to the voters in the ballot measure.
- A Citizens' Oversight Committee was established and will continue to be operational during the life of Measures M and O.
- An annual report is made by the COC to inform the Board of Trustees and community about Measures M and O expenditures and compliance with Proposition 39 requirements.
- An annual financial audit is conducted of the funds until all funds have been expended.
- An annual performance audit is conducted to ensure that funds have been expended only on the projects listed.
- COC membership includes a minimum of seven members with at least one from each of following categories:
  - Parent
  - o PTO member
  - Member of a taxpayers' organization
  - Business organization representative
  - Member of a senior citizen organization
- Members can serve up to three, two-year terms.

# **Purpose of Citizens' Oversight Committee**

- Verify bond proceeds are expended on approved projects specified on the project list.
- Inform the public concerning the expenditure of bond proceeds.

## Oversight Responsibilities include:

- Report to the Board of Trustees annually on the expenditure of Measure M and Measure O funds.
- Inspect school facilities to validate that the bond funds are expended accordingly.
- Verify that no funds are expended on teacher or administrator salaries or other school operating expenses
- Review annual independent financial and performance audits













## **Current Year Citizens' Oversight Committee Activities**

- Annual independent financial audit found the District to be fully compliant
- Annual independent performance audit found the District to be fully compliant
- COC has been on on-site visits to observe completed projects, projects under construction and future projects at all comprehensive high schools
- Special topics on the COC agenda included:
  - Bond refinancing for taxpayer savings
  - o Employee housing project
  - o Property and recommendation for the Location of Peninsula High School
  - Maintenance Operations and Student Nutrition Building
  - District Office
  - Asbestos (transite) panel replacement
  - Maintenance and Operations staffing
  - Non-general bond capital facilities projects
- The financial reports, project updates and schedules were reviewed at each meeting
- Sources of funding for the capital facilities plan for deferred maintenance and the need for sufficient operations and maintenance staff to support the modernized facilities continues to be discussed

### Financial Summary (Estimated) through June 30, 2018

#### **Measure M**

- Measure M was approved for \$298 million
- It expended \$294,850 (99%) by June 30, 2018
- 2017-18 ending balance is \$2,886,124
- \$951K is scheduled to be spent in 2018-19
- \$1.9M is yet to be allocated or expended

#### **Measure O**

- Measure O was approved for \$186 million
- It is estimated \$149,873,456 (81%) was expended by June 30, 2018
- 2017-18 ending balance projected at \$36,126,544
- \$36,126,544 is scheduled to be expended in near future for the District Office, new Peninsula High School (PHS) facility and four years of technology replacement approximately \$28.5 M is available for PHS.
