Public Comment - Open Forum

Commentary on 2016 presidential election and questions related to student anxiety levels.

- M. Zozos: described how the Social Science Dep't approached the results in classes
- C. Beswick: identified concerns from students and leadership's role
- J. Burke: outlined this as an opportunity for tolerance, understanding, inclusion, understanding from different perspectives

- E. Arteaga: outlined murmurs of protests around the student body and that many students are scared of the potential future

Section 1 Summary: Student Safety

Positive results, students sometimes do not acknowledge their own problems, low issues of cyberbullying, #18 - student teacher relationships tend to be polarizing, "remarkable" that 95% of our students are tend not to be victims of cyberbullying

Section 2 Summary: Faculty and Staff Support for and Engagement of Students Faculty and staff giving students a voice, could be improved with outreach on how students can have a voice #26 - 35% not sure to disagree, concerning #29 - overall numbers are high, there are still numbers that could be improved

Section 3 Summary: Culture of Health & Life Balance

Good numbers, #32 self harm from a student's' point of view, #35 sleep (how might 10th/11th graders answer differently?), #34 45% say they can get help for a friend - great!

Section 4 Summary: Culture of Excellence

9th vs 12th views - might not accurately reflect student body High standards might be related to anything, not just school work 34% do just enough to get by (agreement from students)
