4:40	II. Melissa Shadle from Spohn Cancer Research Center Potential Presentation on HPV Information and Vaccinations for Parents, Students and Staff	Teresa Shaw RN
	Expected outcome: Informational and or recommendations Melissa Shadle introduced herself. She explained how she attends health fairs and campuses to educate the community about HPV and the HPV vaccinations. She had the committee complete a pre and post survey about HPV. The survey explained risk factors such as 4 out of 5 people getting HPV. In women, the top HPV cancer site is the cervix and for men it is the oropharynx. HPV is the most commonly transmitted STD in the US. There are about 19,000 NEW cases every day. She discussed prevention methods such as the vaccination doses in great detail. The recommended age for vaccination is 11-12. The committee discussed including this topic at the health fair or during a parent night. Dr. Torres added maybe adding it to the puberty video for Magee. Other suggestions include: Nurses adding to parent notifications 5th grade puberty-required letters Teaming up with Lacey Before Mr. Flores left, he mentioned the need to address dating violence, drugs and alcebel at the accordance level.

	Expected outcome: Informational Started at 5:24 Teresa explained the Skyward Student Check-In system the nursing staff is piloting at the campuses. There was some confusion as to why nurses were checking in students this way, especially at CHS. The issue of germs was also mentioned because student are touching the same computer. Teresa said she has added sanitizing wipes and hand sanitizer but students touching the same computer in the nurses station is no different than students touching the same computer in the computer labs. Teresa also explained how this process is easier and more time efficient. It also lets administrators, faculty/staff know where the student is. For substitutes, she will have the usual paper forms available. She will attend more staff meetings to explain the process in greater detail. Dr Carr expressed her concern about the growing number students using drugs and alcohol and brought up randomly drug testing CHS students. An AP mentioned a popular drug called "Hulk Bars" and suggested banning cell phones instead of the drug testing.
