Project Updates:

IFG provided confirmation that the materials have been ordered for Magee Intermediate and West Intermediate. The anticipated delivery dates for the chain link material is August 16, 2023, and for the Alumni-Guard ornamental fence and gates is October 16, 2023. The card reader access control components for the gates are anticipated to arrive in 30 weeks, and have been ordered for all four campuses. The gate openers are in stock at the IFG warehouse.

The tentative start date for chain link fencing at Magee Intermediate and West Intermediate is August 28, 2023. Both projects should take should take 3 weeks to complete.

IFG will begin ordering materials for East Elementary and Wood River Elementary over the next couple of weeks.

Please note: Calallen High School and Calallen Middle School fencing upgrades require the assistance of an architect and engineer; therefore, these projects will be issued on separate procurements once the design team is in place.

 During the Bond 2023 planning, it was the consensus of the Bond Committee, Bond Advisory Committee, and School Board that Administration would determine how to spend the allotted \$3,112,000 of deferred maintenance budget based on district facility needs assessments. Deferred maintenance includes repairs to roofs, RTUs and A/Cs, parking lots, sidewalks, and plumbing and electrical systems districtwide.
