Evaluation Notes: As a result of the District's recent procurement for CM-at-Risk Services for the Performing Arts Center, the District received two proposals. Both Weaver & Jacobs and Beecroft have extensive years of experience delivering construction services. As illustrated in the table above, four evaluators reviewed, graded, and scored the proposal submitted on the established criteria above.

Both vendors were deemed responsive to the solicitation, and presented proposals which were in line with market rates. All four evaluators gave them good scores based on their experience, overall impression, and reasonableness of cost. After conducting onsite walkthroughs of previous projects for both vendors, it is the consensus of the review team that Beecroft has more experience in building this specific type of Fine Arts facility as well as excess labor capacity to meet the district's timelines.
