Evaluation Notes: As a result of the District's recent procurement for Custodial Services at East and Wood River Elementary schools, two vendors submitted proposals for review. As illustrated in the table above, three evaluators reviewed, graded, and scored the proposals submitted on the established criteria above.

Both vendors were deemed responsive to the solicitation, and presented proposals which were in line with market rates, except for those hourly rates offered by WCD Enterprises for 2nd shift work. \$54.00 per hour for custodial services was deemed as an excessive labor rate.

Multiple references were verified by district staff on AHI's current performance with other organizations. AHI Facility Services is currently contracted with sixteen (16) public schools and universities in Texas and Oklahoma. Therefore, it is the consensus of the evaluation team to recommend them for the requested services pending Board approval.
