6. Mr. Leone noted that in a perfect world we could use approximately 9 more bus drivers. Residential and parochial runs have been consolidated which results in some fuller buses and some runs being 5-10 minutes longer than usual. He also noted that the district actively recruited in the spring and summer months for bus drivers. He said that we do have daily substitute drivers and the transportation department can utilize dispatch as well as the mechanics should more drivers be needed.
