INITIAL PROPOSED PLAN

- Summer Programs beginning this summer, secondary schools, grow years two and three – targeted skills
- Summer Mental Health PYS and PCSD offering counseling (individual and group) – transition, growing years two and three
- Remote learning immunocompromised students programming, costs associated with running a "tenth" school last year, unknown



INITIAL PROPOSED PLAN

- Recruit and retain essential support service positions critically short (bus drivers, maintenance and food service staff)
- Cyber and physical plant security measures & review
- Infrastructure and systems maintenance & repairs
- Food Service Costs & deficit mitigation

INITIAL PROPOSED PLAN

- Equity Coordinator (ongoing inclusivity work and parent engagement)
- Tier 1 Professional Development (instructional strategies)
- Instructional Coaches secondary (differentiated instruction, evidenced based AIS strategies)
- Instructional Challenge MS (gifted learners)
- Additional Mental Health staff resources equivalent to 2.5 staff
- The Plan shall remain flexible and amendment is permissible as additional information, student assessments and agency guidance becomes available. "Plan for Change"
