SBCEO DIVISIONS

<u>Administrative Services Division</u>

Program Manager Meetings: Internal Services is taking steps to prepare for the 2024-25 adopted budget. As part of the process, meetings with all program managers were conducted in early April to identify program goals and planned expenditures.

Program Plans and Funding: Internal Services continued collaboration with the Student and Community Services division on new and revised reporting requirements related to the Local Control and Accountability Plan (LCAP), Learning Recovery Block Grant, Proposition 28 Arts and Music in Schools grant, and the Student Support and Enrichment Block Grant.

School Business Officials (SBO) Quarterly Meeting: The School Business Advisory Services (SBAS) department conducted their quarterly School Business Officials meeting on April 25, 2024. The meeting was focused on the LCAP and included strategies and requirements for completing action tables and identifying expenditures associated with increased and improved services.

Second Interim Financial Report Analysis: SBAS district financial advisors (DFAs) have completed their review of districts' 2023-24 second interim budget reports. Nineteen districts received a positive certification, and one district received a qualified certification. A positive certification means, based on an analysis of the reports submitted, the district can meet its financial obligations in the current and two subsequent fiscal years. A qualified certification is assigned when the district may not meet its financial obligations for the current or two subsequent fiscal years.

E-Safety Network Meeting: SBCEO conducted a meeting for district IT professionals on April 3, 2024. The meeting provided an opportunity for participants to collaborate and share e-safety best practices and resources. The topics addressed included examples of recent K-12 cybersecurity incidents, cybersecurity incident response plans, charts of security recommendations, and examples of artificial intelligence (AI) and student data privacy agreements.

Curriculum and Instruction Division

LCAP Support for Development: The LCAP program team members have been providing customized support to their individual districts as district leaders develop their new 3-year LCAP plans with their educational partners. Customized support documents help each local educational agency (LEA) ensure they are meeting all requirements while crafting plans that align with their strategic plans, continuous improvement efforts, and the needs of their students and families. The LCAP team (program and fiscal) continues to attend biweekly statewide calibration calls to align expectations, troubleshoot questions, and prepare for review and approval. The statewide calls are hosted by SBCEO's associate superintendent of C&I.

Clear Administrative Services Credential (CASC) Program: CASC, the two-year, job embedded coaching-based induction program required for new administrators to clear their credentials wrapped up another year of sessions and classes with Director Dr. Anne Roundy-Harter. Year one candidates will be returning to our program next year to continue their support, training, and induction plans. Our second-year candidates are completing their final assignments to be recommended for their clear credentials. SBCEO has the only accredited CASC program in the county.

Reading and Literacy Added Authorization (RLAA) Grant: We have received a high level of interest from our districts' teachers and leaders for enrollment in the RLAA grant we obtained from the California Commission on Teacher Credentialing (CTC). We anticipate filling our enrollment allocation of 25 teachers the first year and beginning the list for the second year. The CTC provides \$2,500 per teacher, and the district matches the funding for the teachers to complete a yearlong accredited program, grounded in reading science through one of the three universities with whom we have partnerships. Classes will begin this summer.

World Languages Day: Our office hosted nearly 40 World Languages teachers for a deep dive into the newest World Languages framework on April 25. Margaret Peterson, the executive director of the CA World Languages Project at Stanford University and one of the writers of the framework, was the featured presenter.

Student Events: Three separate Battle of the Books events took place this month to encourage deep reading for students in fourth through eighth grades. Elementary battles in both north and south counties, along with a virtual junior high battle engaged more than 250 voracious readers from districts across the county. Students read as many as 28 books from a list and engaged in team competitions to answer questions about characters, plot, and theme. Our final battle – Batalla de Los Libros will convene bilingual students in a virtual battle later in May, answering questions about the Spanish language books they read.

The South County Math Superbowl is the other remaining student event of the school year. Students in grades 4-6 will convene at Earl Warren Showgrounds on May 29 to compete in problem solving and mathematical challenges both individually and as teams. SBCEO partners with Montecito Union, Peabody Charter, and Cold Spring schools to provide this fun event for more than 350 students.

Teachers' Network: Spring is awards season, and we have been busy with grants, awards, and planning. The annual Education Celebration takes place on Thursday, May 23, 2024 at Hotel Corque in Solvang to celebrate multiple award winners, including Crystal Apple awards, Bill Cirone Heart of Education award, and the Marvin Melvin Career Technical Educator awards. It is also an opportunity to bring together our community partners who sponsored teacher grants with the incredible educators who were awarded them and to recognize their initiative and innovation. A live performance will feature the students of 2024 Performing Arts Teacher of the Year, Elesa Carlson. 2024 county and state Teacher of the Year, Greg Wolf, will offer his reflections for the audience as well.

CalMSCS Grant: SBCEO, along with San Joaquin and Monterey county offices of education, leads the California Math, Science, and Computer Science (CalMSCS) Professional Learning Grant for the state. SBCEO is the lead for mathematics, and recently hosted the statewide Math Steering Team for a two-day planning retreat. SBCEO, SJCOE and MCOE have been working with CDE and the grant evaluator to support each of the 58 counties in building sustainable local Communities of Practice

(COPs) for the three subject areas and will begin statewide convenings in the fall. This grant provides \$50 million over 42 months (about 3 and a half years) to build a statewide system of professional development.

Human Resources Division

Workplace Violence Prevention Plan: Human Resources recently completed the SBCEO Workplace Violence Prevention Plan. Recent changes in state law required updates including more rigorous hazard prevention, enhanced communication systems and interactive training of all employees to be implemented by July 1, 2024. Working on this short timeline together with our labor partners, members of the SBCEO Safety Committee and the SBCEO Communications team, a comprehensive plan was written, and employee training was developed. It is expected that all employees will be able to complete the required training and have the opportunity to attend an interactive discussion by the deadline of July 1. As an added service to the school districts in our county, a plan template and employee training template were made available, providing LEAs with a valuable resource as they fulfill the new requirements.

Information Session on Special Education Teaching Credentials: Tom Heiduk, credentials services manager, and Laura Ishikawa, program specialist in Special Education, will conduct an information session on May 30 to encourage non-credentialed staff to pursue special education teaching credentials and inform them of the various support programs available. The long-term goals are to help meet a major staffing need of the Special Education division while providing advancement opportunities for SBCEO staff.

Special Education Division

New Classroom at Casmalia Preschool: On March 11, 2024, a new classroom was opened at the Casmalia Preschool site. This classroom will provide services for 20 students and will help address the growing need for special education services for preschool students in the Santa Maria-Bonita School District and Orcutt Union School District. This is the third classroom at the Casmalia Preschool site. The Casmalia Preschool now serves 65 preschool students.

Spring Meeting for Workability Region 2: Members of our Special Education team attended the Spring Meeting for Workability Region 2 held on April 18, 2024, in Monterey, California. Workability (WAI) is funded and administered by the California Department of Education (CDE) to provide comprehensive pre-employment skills training, employment placement and follow-up for high school students in special education who are making the transition from school to work, independent living, and postsecondary education or training.

The WAI program seeks employers in the business community who will provide students with disabilities with opportunities to work in an integrated employment setting. WAI offers students with an Individualized Education Program (IEP) the opportunity to complete their secondary education while also obtaining marketable job skills. This CDE

grant program focuses on providing secondary students with an understanding of job-seeking and job-keeping skills with the expected outcome of improving employability. Students in WAI receive occupational class training and on-the-job subsidized or unsubsidized work experience.

Spring Job Fair Hosted by Vandenberg Space Force Base: On April 24, 2024, Vandenberg Space Force Base hosted their Spring Job Fair. This event was created for employers, nonprofits, and agencies in the Lompoc area to offer their current employment opportunities to the spouses of military personnel. SBCEO Special Education division leadership staff attended the event to share employment opportunities within the SBCEO Special Education division.

Student and Community Services Division

Career Technical Education (CTE) Teacher Tours: The teacher tours of local businesses and industries continue. The next north Santa Barbara County tour is on May 8 and will include the Business, Finance, and Marketing Industry Sectors. The next south Santa Barbara County tour will be on May 31 and will include the Hospitality, Tourism, and Recreation Industry Sectors. Board members are welcome to attend.

Children's Creative Project (CCP)

I Madonnari Festival: This year's festival will honor Margie Yahyavi, an arts and education advocate who recently passed away. Margie was a champion for student success especially during her years as executive director for Santa Barbara Education Foundation. The festival will be May 24-26 from 10 a.m. to 6 p.m. A special ceremony will take place at noon on Monday, May 26 where both Associate Superintendent Bridget Baublits and CCP Director Kai Tepper will present.

CCP is Growing - New Staff Member and New President of the Board of Directors - and an Upcoming Community Event: CCP is excited to announce that Yoseline Gonzalez has joined the team. Yoseline was born and raised in Santa Barbara and attended local public schools. She joins the team after spending several years doing important work at United Way. CCP recently voted on a new officer slate for their board of directors. Beginning July 1, Bryan Kerner will be stepping down as president and Genevieve Badone-Assili will be stepping in. A "Kids at the Bowl" presentation has been confirmed in partnership with the Santa Barbara Bowl. CCP and the Bowl will be presenting "Dancing Wheels Company," on October 1 at 10:45 a.m.

Early Care and Education (ECE)

ECE Staff Retreat: ECE held a staff retreat on March 29 and 30, 2024 in San Luis Obispo. This retreat aimed to foster team bonding, boost morale, offer professional development, and strengthen connections among staff across our 11 school sites.

The retreat began with a team decision-making activity, followed by training sessions led by SBCEO School Safety Liaison Dennis Thomas on Standard Response Protocols

and "Stop the Bleed" certification. Staff also received ALICE lockdown training with practical demonstrations to empower them in crises. The following morning, they engaged in a Classroom Assessment Scoring System (CLASS) training session led by Monica Thorpe, Quality Counts manager, focusing on enhancing concept development in classrooms. Feedback from staff has been overwhelmingly positive and expressed their gratefulness for the opportunity to provide this enriching experience.

Recognizing ECE Staff During Teacher Appreciation Week, May 6-10: Each year, the first full week of May is Teacher Appreciation Week. The Santa Barbara Child Care Planning Council will deliver letters of appreciation to local preschool educators and family child care providers. This year, we will provide 872 letters to 79 programs across our county. The planning and implementation required to make this happen is only possible through our close partnerships with directors, providers, and community partners.

The certificated and classified personnel reports are provided to the board as an information item.

Certificated Personnel Report

Certificated employees are those whose positions require a specific credential issued by the California Commission on Teacher Credentialing.

The certificated personnel report is generated regularly and includes all actions made regarding employment of certificated employees at SBCEO such as appointments and separations.

Classified Personnel Report

Classified employees are those whose positions do not require a state-issued credential. Since 1975, the Santa Barbara County Education Office has operated a Merit System for the classified service. Merit System law (Education Code § 45240-45320) provides that classified employees are selected, retained and promoted on the basis of merit and fitness, exclusive of discrimination due to actual or perceived race, color, ethnicity, age, religion, political affiliation, marital status, disability, gender, sexual orientation or national origin. The Personnel Commission, composed of three members, is the impartial body authorized by the state to be responsible for implementing and interpreting Merit System rules and adjudicating appeals on those facets of employment within its purview.

The classified personnel report is typically generated monthly and includes all personnel actions affecting classified employees at SBCEO such as appointments, changes to status, and separations.
