- Current budget to budget would be 1.74%

- Could we save money on BOCES line of computer fiber optics services?
- Cutting sports, summer reading and band camp are things people will come out to vote for
 - Thinks vote will be close and staying positive is important Athletic Director should look elsewhere to cut. Some High School teams pull up Middle School kids
- Cheerleading had a very successful year
- What do 4.9 teachers translate to? And 5 elementary?
- Another resident spoke in support of cheerleading the number of students outweighs savings; numbers are growing in Seaford.
 She suggested not going to away games to save money
- When we cut elementary technology how do we address standards? She also asked about our expenditures for full-time kindergarten and State funding. Foundation aid has been frozen since 1st year. Full-time kindergarten is still not a mandated program. Will this be pushed back because of frozen aid?

How are grants doing?

Cheerleading should try to be recognized as a sport

- A resident stated she was upset over Math Clubs and Mathletes
- Band Camp is a necessity new music wing for music
- A resident stated that she did not know Italian be might cut when her child signed up

Maybe cheerleading could cut fall season

- Italian commitment was made only for kids in program Elementary Restructuring
 - What is happening with the Seaford Avenue School?
 - What role did Budget Advisory Committee play?
- How did you decide which ones to cut when going through the teams? Did you consider salaries and equipment?

Mr. Conboy explained that 4.9 teachers – Math teacher in the High School, another retirement, foreign language and other partials. 5 Elementary is 2 classrooms, SAILS, technology teacher, reading teacher
