Other option - Take out air conditioners and vents in library, put in glass and rooftop air conditioner.

- Look into painting panels on gym roof Going forward:
- Leave air conditioners alone; check price on putting vents in ½ panel window
- Suggest landscaping plan for front to address issues

### High School Special Education Wing:

- Ceiling height change led to window design change
- Windows will be brushed aluminum with cream top panel
- In replacing windows 4 bays will be replaced with 2 sliding windows with top transom
- Have not looked at air conditioners yet. Can be put on transom or in single side of slider as fixed window – in cream panel

#### Harbor Roadway:

- Planning Commission and Nassau want us to take extra piece of property
- About 47,000 square feet
- Open Space commission wants us to use extra area as an outside teaching area
- Will come up with a 2 alternatives one straight road; one curved road.
