At 7:31 p.m., the President of the Board of Education called the Workshop Meeting to order. As the first order of business, Board President Brian Fagan led the audience in the Pledge of Allegiance.

Topics covered in Mr. Conboy's Administrative Report dated January 14, 2011 included:

ADMINISTRATIVE REPORT

Seaford Avenue School:

Meeting with Supervisor Kate Murray to discuss the Seaford Avenue School building and property

- Mr. Conboy, Mr. Kahn, Mr. Aldrich and Mr. Ward met with Supervisor Kate Murray, Chief of Staff Ray Mineo and Assistant Reid Berglind from the Town of Hempstead to discuss the Seaford Avenue building and property
- Town of Hempstead has very little funding to devote to projects
- Does have some money earmarked over time for Camp Anchor
- Seaford is the only town with a turf field paid for by the Town of Hempstead
- Supervisor Murray's belief is that senior housing is the best way to go
- Does not appear that the Town of Hempstead will be of any help to us concerning the Seaford Avenue School

Results of the Seaford Avenue School Survey will be printed in the winter newsletter

Harbor School Driveway:

- If we move forward with SEQRA on February 3rd we are hopeful that we will be able to put some additional information about the Harbor Driveway in the winter newsletter
- Once the SEQRA process is completed we still have to ask the voters for permission to use the leftover bond money for the project, the County needs to transfer the land and the State Legislature needs to issue the Alienation of Parkland decision:
- We can have discussions as to when the vote should take place after the SEQRA process is completed; we do not have to wait for the County or the State

Letters will then be sent to Senator Fuschillo and Assemblyman McDonough specifically asking them for assistance with issues relating to the Alienation of Parkland which can be a lengthy process

If voters give us permission to spend the money which has already been approved we will at least have the security in knowing that we can spend that money when the Alienation of Parkland comes through

Latest issued with the SEQRA involves that small piece of tidal wetlands

County attorney and Ingerman Smith feel we are close to being completed and hope to have on the February 3rd agenda the resolution for Seaford to be named as the lead agency for SEQRA and have the negative declaration for environmental impact

Hamburger, Maxson, Yafee, Knauer & McNally Agreement:

Board questions and concerns:

- Maximum cost to Seaford if 20 school districts are participating
- Is the cost of an appeal included in the maximum dollar amount stated in the contract; Board would like that clarified
- Concerns over the contract:
- How many districts are participating
- Would it be recommended to do an RFP in these circumstances
- What will be the role of the School Boards in this process?
- Who is the lead spokesperson for this
- Seaford's tax certiorari impact
- Rather than divide the cost equally among the participating districts wouldn't it make more sense to base it on the percentage of the 82.3 million dollars which is being passed on to school districts and each district be billed proportionately
- Concerns over the legal services provided and the contract
- In favor of the lawsuit and do not want to hold this up but feel it is not unreasonable to ask further questions get more solid answers
- Equally important is that Mr. Sapraicone and Mr. DelGiudice are not present this evening and waiting to February 3rd will be more representative of the Board and fairer to them

Administration:

- Effort by Nassau County Superintendent's Association and Nassau/Suffolk School Boards Association to obtain legal counsel to join a lawsuit to overturn the County Legislature's decision to pass the responsibility for tax certioraris to school districts.
- Ingerman Smith and Guercio & Guercio believe the County's actions were unlawful.
- Lawsuit was originally envisioned by Ingerman, Smith and Guercio & Guercio but due to conflicts stemming from their representation of so many districts on Long Island it was decided that other counsel should be hired
- A Joint venture and the Executive Council of Nassau/Suffolk School Boards and Executive Council of the Nassau County Superintendents interviewed two law firms and decided to go with the Hamburger, Maxson, Yafee, Knauer & McNally firm
- It would be difficult for some districts with larger liabilities to set aside that large of an amount in their operating budget
- A letter came from Superintendent's Council and a similar letter came from Nassau/Suffolk School Boards
- Mr. Conboy stated that he and Mr. Fagan had spoken and felt that there has to be a esprit de corps among organizations which are challenged by the same things legislatively
- He also stated good questions were being asked and he didn't feel there was a tremendous negativity in waiting until February 3rd board to get additional information on this

School Attorney

Attorney Maryanne Sadowski explained the criteria used in selecting the firm, substantively a proposal for services was requested and when asked stated she was satisfied with the process used in the selection. She also stated a formal RPF was not required.

Ms. Sadowski said typically in these matters the fee is split equally not equitably. She also stated that there is no guarantee that all 56 school districts will sign on to the lawsuit and to come up with an agreement which takes into account each of those various scenarios the approach was to keep it as simple as possible and distribute it equally to those who participate

2011-2012 Budget:

- Until we see Governor's proposal due on February 1 level of program cuts necessary are unknown
 - We don't know if a 2% tax cap would be with the same state aide as last year (already reduced because ARRA funds are no longer part of that) or a reduction in state aid and a 2% tax cap or is it a budget to budget cap or a tax levy cap
 - Interested in finding out more information on mandate relief but that committee isn't scheduled to report to the Governor until March 1st
- Mr. Aldrich has prepared some numbers with known budget increases and impact of a 2% and a 4% budget-to-budget and tax levy cap with the same state aid keeping in mind last year's cuts
- This year will be a very unique year
 - Most districts are in holding pattern until Governor's proposal is known
- Assemblyman McDonough asked what we though the impact of a 2% cap would be and what I thought the impact of a 4% cap would be (4% cap had in previous years been passed by the State Senate)
 - There will be a great deal of legislative dialogue after the Governor puts out his proposal

Nurses contract for our five nurses expires at the end of this school year Letter from Ingerman Smith advising us of rate increases for the 2011-2012 school year

Can some kind of clause be put in the contract for the services even if a district is not named in the filing? Is there a way to find as a certainty if the agreement can or cannot be amended this way?

Mr. Kahn asked if the petitioner name would be all Nassau County districts or just those participating and was advised that it would only be the participating districts.

Ms. Sadowski stated that she did not believe the letter of engagement precluded that but the issue is that papers need to be filed by March 1st. Ms. Sadowski briefly explained the process of filings, timelines, costs incurred in amended filings, cost of suit and benefit to case when knowing how many districts they are presenting and the dollar amount impacting those districts. Up until some point districts could join but better practice that they are all in at once. Part of the issue is if you sign on after all of the papers are drafted and filed the extent of legal services to be provided will be governed by the County's response. If districts sign on after the filing there would be some issue of the about them paying for services provided in the front end. It is going to be very hard for a district to come in we; after the filing. They are going to need to know who is in prior to the filing of that lawsuit. Every District in Nassau will either benefit or not benefit from the outcome of the lawsuit. The participating districts will individually be listed as Petitioners.
