RESOLUTION – PROPOSITION – REPAIR RESERVE FUND

BE IT RESOLVED, that the resolution adopted by the Board of Education at its public meeting on April 6, 2006 approving the placement of a proposition to establish a repair reserve fund before the qualified voters of the Seaford Union Free School District at its annual budget vote and election on May 16 2006, is hereby rescinded; and

BE IT FURTHER RESOLVED, that the Board of Education hereby creates a repair reserve fund pursuant to General Municipal Law Section 6-d; and

BE IT FURTHER RESOLVED, that the Board of Education shall place before the qualified voters of the Seaford Union Free School District at is annual budget vote and election on May 16, 2006, a proposition authorizing the funding of the repair reserve fund; which proposition shall read in substantially the following form:

"Shall the Board of Education be authorized to transfer \$210,000 from its fund balance for the 2005-06 school year to its repair reserve fund for repairs to the High School Auditorium, including repairing (not replacing) the seating, new carpeting and painting; which transfer of funds shall not cause an increase in taxes".

BE IT FURTHER RESOLVED, that the District Clerk is directed to amend the legal notice of the annual budget vote and school election to include the text of the afore-described proposition, and to take all necessary steps to include the proposition on the ballot for said annual budget vote and school election.
